The Cathedral Chapter at Minden and its Members, 1650-1803

Prior to the Thirty Years War, the cathedral chapter at Minden was virtually indistinguishable from others in north-central Germany. Minden was an ecclesiastical principality which had become predominantly Protestant in the course of the sixteenth century, with a chapter composed of a varying number of Catholic and Protestant canons, and with the princely authority exercised by a bishop-elect or administrator from a neighboring princely dynasty, usually a Duke of Brunswick or a Count of Schaumburg, with Protestant leanings and no chance of investiture from Rome. During the war, the Catholic Franz Wilhelm von Wartenberg obtained possession of the bishopric as a result of intervention by the Emperor, and the Catholics began to increase their membership in the chapter.¹ In 1648, when the Thirty Years War came to an end, Wartenberg was still Prince-Bishop of Minden, and the chapter had only four Protestants among its 24 members.²

The Peace of Westphalia, which ended the war, however, secularized the principality in order to compensate the Great Elector of Brandenburg for the loss of Hither Pomerania to Sweden, and specified 1. January, 1624, as the "normal year" for determining possession of ecclesiastical properties and revenues, including prebends in cathedral chapters.³ At that time, the chapter of Minden was composed of 13 Protestants and only 11 Catholics.⁴ In the detailed provisions made for implementing the peace settlement, further changes were made. One quarter of the prebends at Minden were to be suppressed to the benefit of the electoral treasury, and the elector was granted considerable authority over the membership and officials of the chapter.⁵ Prior to this arrangement, as in all German chapters, vacancies which occurred during odd months (January, March, May, etc.) were filled by papal provision, while those occurring during even months were filled by members of the chapter itself acting as Turnarius in order of seniority. After 1650, the vacancies occurring during odd months were to be filled by collation by the Elector. Moreover, whereas heretofore the chapter elected its

own chief dignitaries (provost, dean, etc.), now the Elector had the right to select the provost, although that dignitary had to be, as he was in 1624, a Catholic. The chapter retained the right to elect the dean, whose office dealt with the internal affairs of the chapter rather than with external relations, as in the case of the provost.⁶

The precise order in which changes in the composition of the chapter were to take place is not entirely clear. The most likely method, however, and one which seems justified by the data available about the various members of the chapter, is that the first six vacancies after 1650 were not filled, but were suppressed to the benefit of the electoral treasury. All the prebends suppressed to the benefit of the electoral treasury were counted as Protestant prebends, so that there were to be eleven Catholic capitulars and seven Protestant ones in the new chapter. Even after the suppression of the first six prebends which fell vacant, however, there remained only four Protestant members of the chapter, so the next three Catholic vacancies logically should have been filled by Protestants to reach the requirements of the peace settlement. This does not seem to be the way it was handled, however. By 1660, six prebends had fallen vacant and been suppressed to the benefit of the electoral fisc, as expected. However, when two prebends became available in 1664, they were not given to Protestants, but rather to Catholics. Neither does it appear that the three most junior prebends were reserved for the Protestants, and thus it remains something of a mystery as to the exact method employed to achieve the balance required by the Westphalian settlement.

In 1665, after two new Catholic canons had been admitted to the chapter, a further alteration in the membership was made in agreement between the chapter and the Elector. Much of the revenue of the chapter had been lost as a result of the Reformation during the sixteenth and seventeenth centuries, and thus it was agreed that three more prebends would be suppressed, two Catholic and one Protestant, reducing the number of prebends to fifteen. The revenues from the suppressed prebends was to be redistributed among the fifteen canons remaining in the chapter.⁷

No sooner had this agreement been reached, however, when still further changes were introduced in the form of so-called "family prebends". The first was proposed by the militantly Catholic Prince-Bishop of Münster, Christoph Bernhard von Galen, who was also a member of the chapter at Minden. In return for an endowment, initially proposed at 5,000 Reichstalers but then raised to 8 000, the head of the house of Galen would have the right to nominate a member of the chapter, who in all other respects would be indistinguishable from the other capitulars.⁸ The first Galen Family Prebend was proposed in 1665, perhaps in

response to the suppressions agreed upon in that year, but was not actually filled until 1669. A second Galen Family Prebend was added to the chapter at Minden in 1677, and in 1689 the Protestant family von dem Bussche zu Hünnefeld established a third family prebend.⁹ These changes brought the total membership of the chapter at Minden back up to eighteen, the number agreed upon in 1650, with eleven Catholics and seven Protestants among the canons.¹⁰ By 1689, also, the correct number of Catholics and Protestants had been reached, and so the chapter had at last attained a stable membership, which it would retain until the suppression of the entire body in 1810.

During these same years, a controversy arose concerning the dignity of dean of the chapter. In the "normal year" of 1624, the Protestant Herbord von Langen had been dean of the chapter, but had announced his intention of resigning.¹¹ He was succeeded by the Catholic Johann von Cappel, who died in 1633, ¹² and was in turn succeeded by the Catholic Jobst Friedrich von Vincke,13 who was dean at the time of the Westphalian settlement. When Vincke died in 1660, the chapter, still predominantly Catholic, elected as his successor another Catholic, Johann Adrian von Wendt.¹⁴ The Elector of Brandenburg protested that, under the "normal year" arrangement, the dean was to be Protestant, but the chapter took the position that the "normal year" provisions applied to the number of members in the chapter but not to the dignities.¹⁵ This controversy would last for over a quarter century. Under continuous pressure Wendt resigned at the beginning of the year 1670, but on 8. May of that year the chapter elected another Catholic, Jobst von Valcke.¹⁶ Despite the continuous protests of the Elector, Valcke served as dean for the next sixteen years. Finally, in 1686 upon the death of the provost, Johann Rotger von Torck, the Elector transferred Valcke to that dignity and ordered the election of a Protestant dean.¹⁷ The chapter complied with the election of Albert Clamor von dem Bussche on 6. December, 1686.18 Although controversy arose anew when Bussche died in 1710,¹⁹ the Elector had won the point, and all subsequent deans were Protestants.

Despite the religiously mixed composition of the cathedral chapter at Minden, it continued to function under the pre-Reformation rules as a single body, although those rules were adapted somewhat to meet the altered circumstances. Canons in residence were required to attend choir services, held in the Catholic manner, but led after 1686 by a Protestant dean. In lieu of tonsure, a canonical requirement for membership, the Protestant members paid a fee to the chapter treasury, and after 1687 Protestants were no longer required to attend Mass or take part in Catholic processions, but merely had to be present in the cathedral immunity during those rites.²⁰ At some as yet undetermined point, the canonical requirement of celibacy was waived for the Protestant members as well. The earliest record of a married canon at Minden is Heinrich Victor von Korff zu Waghorst, who married in 1705.²¹ With these adaptations, the chapter continued to function as before the Reformation despite its religiously mixed composition.

Two factors complicate the determination of membership in the cathedral chapter from the materials preserved in the Staatsarchiv in Münster. The first is the practice of the chapter of assigning to members of the Minden Ritterschaft the task of carrying out the investigations into the proofs of nobility required of candidates. Thus, we find that in 1673 Hermann v. Dinklage, Wilhelm v. d. Recke, Philipp Heinrich v. Wrede, and a Herr v. Syberg were assigned to investigate the claims of Heinrich Victor v. Korff,²² which may account for the presence of the name Wilhelm v. d. Recke in the Culemann list,²³ although there ist no evidence from the Acta that such a person was a member of the chapter, and there ist no place for such a capitular in the Sitzreihe. This error was repeated by Fahne and Hersche.²⁴ The Wilhelm v. d. Recke mentioned is undoubtedly the lord of Stockhausen in the Principality of Minden, not a member of the Steinfurt branch of the family, as indicated by Culemann. This same procedure can be seen many times in the Acta, e. g., for Ferdinand Benedict von Galen in 1716 the probe was carried out by a committee consisting of v. Korff, v. Munch, v. Hanxleden zu Eickel, v. d. Recke zu Stockhausen, v. Friesenhausen zu Amerkamp, v. Schele zu Schelenburg, and v. Schele zu Kuhof.²⁵

The second complicating factor is the practice of the Elector of Brandenburg (later King of Prussia) of holding prebends vacant for long periods, and assigning the revenues to favored military officers. For example, the prebend vacated by the

Westphalen in 1720 was not filled until 1727. In the meantime, the revenues were enjoyed by a v. Sonsfeld.²⁶ Similarly, in December, 1777, King Frederick II of Prussia confirmed the collation of Valentin Ernst Ludwig v. d. Recke as a member of the chapter,²⁷ but on August 25, 1779, Recke was still having problems obtaining the revenues of his prebend from Colonel Leipziger of the Kellerschen Infantry Regiment.²⁸ This practice led Nottarp to state that in 1752 a Schönberg and a Wopersnow were members of the chapter,²⁹ although the Acta gave no support to that statement.

Despite these difficulties, the following list represents the most likely reconstruction of the membership of the chapter at Minden during the years between 1650 and 1803. While there remain several questionable areas, at least the outlines of membership in the chapter, and many individual facts about the capitulars, are based solidly on the archival materials.

Prosopography of Minden Canons*

1 Neuhoff, Johann Georg von

Son of Stephan v. Neuhoff zu Horstmar and Margarete v. Canstein³⁰ this DH was a Catholic who entered the chapter in 1609³¹ and died in 1659.³² He was elected as DP in 1622, although in Culemann's list³³ he is recognized only from 1624. Nonetheless, Culemann records the death of his predecessor in 1622, and in Beckschäfer's list of DHH on January 1, 1624³⁴ he is listed as DP. Johann Georg was great-uncle of Jacob Leopold v. Neuhoff (34). He was also DH in Hildesheim.³⁵

2 Vincke, Jobst Friedrich von

Son of Johann v. Vincke zu Kilver and Margarete v. Fullen,³⁶ Vincke was admitted to the chapter in 1603.³⁷ In 1633 he was elected DD.³⁸ In addition, he was DH in Osnabrück³⁹ and Propst zu Quakenbrück.⁴⁰ Himself a Catholic,⁴¹ Jobst Friedrich was cousin of the Protestant Johann Heinrich v. Vincke (5). Upon the death of Vincke on 21. June 1660,42 this prebend was extinguished to the benefit of the Electoral treasury.⁴³

3 Mallinckrodt, Bernhard von

Born 29. November, 1591, the son of the Protestant Heinrich v. Mallinckrodt zu Küchen and Remberta v. Krevet, Bernhard converted to Catholicism in 1616.⁴⁴ At that time, he was already DH in Minden, having received his prebend in 1602 from his uncle, the Minden DD Eberhard v. Mallinckrodt.⁴⁵ In 1630 Bernhard was elected coadjutor to the Bishop of Minden, but the elected was invalidated.⁴⁶ In 1650 he was the most significant rival to Christoph Bernhard v. Galen in the election in Münster, where he was DD.⁴⁷ Mallinckrodt died on 7. March, 1664,⁴⁸ imprisoned by Galen, and as Senior of the Minden chapter.

4 Ledebur, Johann Dietrich von

Son of Johann v. Ledebur zu Stockum⁴⁹ and Gertrude v. Billerbeck⁵⁰ and a Catholic,⁵¹ he was "ad possessionem admissus 16. August, 1622."⁵² At the time of his death on 2. January, 1670,⁵³ he was Sch. and sub-Senior.⁵⁴

5 Vincke, Johann Heinrich von

Although included in Hersche,⁵⁵ and therefore counted as a Catholic, Vincke is listed as Protestant by Beckschäfer.⁵⁶ His father, Idel Jobst v. Vincke zu Ostenwalde,⁵⁷ converted to Protestantism in 1597 and married Catharine v. Dinklage,⁵⁸ a member of a Protestant family. Moreover, in order to achieve the 13 Protestant DHH required in 1624, Johann Heinrich must be counted as Protestant. Hersche also lists his date of admission as 1624,⁵⁹ but his inclusion in Beckschäfer's list of DHH on January 1, 1624, and his place in that list would indicate an earlier admission. In 1648 he was also Gross-Vogt in Minden and Propst zu Levern.⁶⁰ Johann Heinrich is an uncle of Johann Dietrich v. Vincke (35). He died in 1680.⁶¹

6 Schele, Caspar Adam von

This Protestant⁶² DH was a son of Adam v. Schele zu Schelenburg and Catharine Clara v. Wulfen.⁶³ He was presented in the chapter in 1623 by Duke John of Brunswick, and was minor praebendatus in 1624.⁶⁴ At the time of his death on 21. April, 1673,⁶⁵ he was Mindenscher Landrat and Senior of the chapter.⁶⁶ He is uncle of Christian Philipp v. Schele (51), and was succeeded in his prebend by Heinrich Victor v. Korff (32).⁶⁷

7 Gertzen gnt. Sintzig, Johann Wilhelm von

This scion of the Rhineland was a son of Johann Otto v. Gertzen gnt. Sintzig zu Sommerberg and Maria Kolff v. Vettelhoven.⁶⁸ He was a Catholic, and a member of the chapters at Münster⁶⁹ and Paderborn, in the latter of which he rose to the dignity of DP.⁷⁰ Culemann records that he obtained possession of his prebend on 23. August, 1624, but also says he died in October, 1636,⁷¹ which is in error, as we find him in Münster and Paderborn much later, with his death on 1. May, 1664.⁷² Becker-Huberti and Kohl record that he was nearly 100 years old at the time of his death.75

8 Westphalen, Wilhelm Dietrich von

This DH was sworn in on 21. August, 1627,⁷⁴ as a catholic member of the Minden chapter, and retained his prebend until his death in 1660.75 He was a son of Heinrich Leo v. Westphalen zu Lichtenau and Theodora v. Plettenberg,⁷⁶ and a cousin of Heinrich Dietrich v. Westphalen (47). According to Hersche, he was also DH in Mainz.⁷⁷

9 Wrede, Heinrich Alexander von

A son of Caspar v. Wrede zu Amecke and Agatha v. Korff-Schmising,⁷⁸ Wrede was cousin of Johann Adolf v. Korff-Schmising (23) and great-uncle of Caspar Ernst Rotger v. Wrede (55). He was a Catholic. Sworn in on 5. June, 1631,⁷⁹ he served until 1668.⁸⁰

10 Galen, Christoph Bernhard von

The famous Prince-Bishop of Münster has been written about extensively.⁸¹ He was born to Protestant parents, Dietrich v. Galen zu Bisping and Catharine v. Hörde,⁸² on 12. October, 1606, but the family became Catholic while he was still a youth. He received his prebend in Minden by collation of Pope Urban VIII on 18. October, 1631,⁸³ and continued as a member of the chapter until his death on 19. September, 1678.⁸⁴ He and his brother Heinrich founded the Galen Family Prebends. Christoph Bernhard was uncle to Ferdinand Benedict v. Galen (67), Karl Anton v. Galen (83), and Raban Wilhelm v. Schilder (30).

11 Nehem, Johann Eberhard von

The family name is also given as Neheim, Nehen, and Nehm.⁸⁵ Johann Eberhard was a son of Dietrich v. Nehem zu Sondermühlen, in the Bishopric of Osnabrück, and Elisabeth v.

Korff,⁸⁶ and uncle of Dietrich Heinrich v. Nehem (26). He obtained possession of his prebend in Minden in 1633,⁸⁷ and was also DH in Osnabrück.⁸⁸ He died on January 11, 1674, at the age of 67.⁸⁹

12 Horst, Johann von der

The family v. d. Horst had its origin in the Vest Recklinghausen, but held the office of Droste zu Vlotho in the County of Ravensberg for at least four generations. Johann was a son of the Droste zu Vlotho Arnold Franz v. d. Horst zu Hellenbroich and Anne Margarete v. Reuspe,⁹⁰ and uncle of Adrian Christian Wolfgang (40) and Maximilian Ferdinand Anton (53). He obtained possession of a prebend in Minden on 10. January, 1634,⁹¹ but lost that position in 1654⁹² as a result of his marriage to his cousin, Maria v. d. Horst zu Milsen. Johann was Catholic.⁹³

13 Ketteler, Goswin von

This DH was a son of Goswin v. Ketteler zu Middelburg, who married in 1615 Christine v. Korff-Schmising, heiress of Harkotten.⁹⁴ Goswin obtained a prebend in Minden on 16. June, 1635,⁹⁵ and is recorded in the Ordo Canonicorum for 1660.⁹⁶ Fahne records a brother, Hermann, as DH in Minden who died in 1667.⁹⁷ While there is no evidence to support this assertion, 1667 may be the date of the death of Goswin. Ketteler was Catholic, and uncle of Friedrich Christian (70).

14 Schilder, Eberhard Adrian von

Although the Mind AT gives the names Eberhard Adrian, Culemann and Hersche record him as Hermann Levin.⁹⁸ He was a son of Wilhelm v. Schilder zu Dreckburg and Eva Margarete v. Hörde zu Eringerfeld,⁹⁹ although Fahne mistakenly places Eva Margarete in the Schwarzenraben branch of the Hörde family.¹⁰⁰ Hersche notes that his religious affiliation is uncertain.¹⁰¹ He obtained possession of his prebend on 13. December, 1635, and was emancipated in 1654.¹⁰² Schilder was uncle of Raban Wilhelm (30). Hersche lists his exit from the chapter in 1658,¹⁰³ and he does not appear in the Ordo Canonicorum for 1660.

15 Dinklage, Jobst Dietrich von

Scion of an influential Protestant family of the Bishopric of Osnabrück, Jobst Dietrich was a son of Gerhard v. Dinklage zu Schulenburg and Beata v. Korff.¹⁰⁴ His uncle, Jobst, had

been a member of the chapter, dying in 1649 or early 1650, and his grand-nephew, Eberhard Hermann Jobst (043), would succeed him in his prebend.¹⁰⁵ Dinklage was sworn in on 9. December, 1639,¹⁰⁶ and was Senior by 1677.¹⁰⁷ He died on 27. July, 1691.¹⁰⁸

16 Valcke, Jobst von

Son of Ludolf v. Valcke (Falcke) zu Rockel, in the Bishopric of Münster, and Johanna Maria v. Neuhoff,¹⁰⁹ Jobst was a nephew of the DP Johann Georg v. Neuhoff (1). Nottorp says Valcke was Protestant,¹¹⁰ but this is an error influenced by the fact that he was DD before becoming DP. His parents were married in 1615, and the young nobleman became a member of the Minden chapter in 1640.¹¹¹ Although Hersche says he left the chapter in 1658,¹¹² Jobst was elected DD on 8. May 1670,¹¹³ and then was transferred to the dignity of DP in 1686.¹¹⁴ He was the last Catholic dean at Minden. According to Nottarp, he was succeeded as DP by Heinrich Wilhelm v. Wendt (31) in 1692.¹¹⁵ He resigned his prebend on 28. August, 1693, in favor of his nephew, Christoph Bernhard (45),¹¹⁶ whose brother, Michael Gottfried (36) was also a member of the chapter. He lived until 1701, married, and had a son.

17 Wendt, Johann Adrian von

This DH is given several times in the Acta as Johann Wilhelm. He was a son of Matthias v. Wendt zu Holtfeld and Mechtild v. Leerodt,¹¹⁷ grand-nephew of Jobst Adrian v. Wendt, a member ot the chapter who died in 1637, although Fahne confuses the two,¹¹⁸ brother of Heinrich Wilhelm (31), and great-uncle of Franz Arnold (72) and Wilhelm Adolf (82). The Wendts zu Holtfeld were among the most prominent Catholic families of the County of Ravensberg. Johann Adrian was presented by Johann Dietrich v. Ledebur (4) as Turnarius on 16. August, 1640,¹¹⁹ for the position vacated by Johann Christian v. Wrede,¹²⁰ and was sworn in on 14. September, 1643.¹²¹ He was elected DD on 18. August, 1660,¹²² but resigned on 3. January, 1670.¹²³ He was also DH in Osnabrück¹²⁴ and Halberstadt¹²⁵ and Propst zu Levern.¹²⁶ Wendt died in 1694 at the age of 64,¹²⁷ and was succeeded in his prebend by Heinrich Dietrich v. Westphalen (47).¹²⁸

18 Korff, Jobst Heinrich von

From the Catholic branch of this family with its seat at Sutthausen in the Bishopric of Osnabrück, of which Jobst Heinrich was briefly possessor,¹²⁹ this DH was a son of Dietrich v. Korff and Gertrude v. Ledebur.¹³⁰ He was sworn in as a member of the Minden

chapter on 2. March, 1641,¹³¹and was also DH in Osnabrück.¹³² He died on 12. February, 1687,¹³³ being succeeded in his prebend by Adrian Christian Wolfgang v. d. Horst (40).¹³⁴

19 Torck, Johann Rotger von

This learned scion of an old family of the Münsterland was a son of Rotger Dietrich v. Torck zu Vorhelm and Asbeck and Anne v. Schencking zu Bevern.¹³⁵ He became DH in Minden on 29. May, 1643, ¹³⁶ and was later appointed as DP in 1659. ¹³⁷ In addition, he was DD and Vicar-General in Münster¹³⁸ and DH in Paderborn.¹³⁹ He died on 5. September, 1686, at age 58,¹⁴⁰ although Fahne¹⁴¹ incorrectly records his birth as 1608.

20 Fürstenberg, Franz Egon von

Not to be confused with the Fürstenbergs of Westphalia, this DH was a scion of the Swabian family of the same name, a son of Landgraf Egon v. Fürstenberg zu Heiligenberg and Anne Maria v. Hohenzollern.¹⁴² He was born on 18. April, 1626, and died on 1. April, 1682.¹⁴³ Franz Egon was a strong supporter of the Bavarian electors of Cologne, where he served as chief minister, and of alliance with France. His career is charted in O'Conner's biography of his brother, Wilhelm Egon. He was sworn in at Minden on 19. March, 1644,144 and also was DH in Hildesheim, Köln, Liège, Speyer, and Strassburg, and Prince-Bishop of Strassburg.145

21 Nassau, Johann Ernst von

Son of the Catholic convert Johann Ludwig Graf v. Nassau zu Hadamar and Ursula Gräfin zur Lippe,¹⁴⁶ Johann Ernst was born on 25. October, 1631, and died on 28. September, 1651.¹⁴⁷ Although Hersche gives his entrance into the Minden chapter as 1649, probably based on Culemann,¹⁴⁸ the AT record his swearing in in 1644.¹⁴⁹ Johann Ernst was also DH in Münster, 150 Osnabrück, 151 Köln, and Strassburg. 152

22 Aschebrock, Franz Conrad von

Recorded in the Acta as Ascheberg, and repeated as such by Culemann¹⁵³ and Hersche,¹⁵⁴ this DH was nonetheless a son of Jobst Wilhelm v. d. Dorneburg gnt. Aschebrock zu Mahlenburg and Henrica v. Hatzfeld, who were married in 1608.¹⁵⁵ Culemann records that

he succeeded Caspar v. Korff-Schmising "ex provisione Apostolica 2. Maii 1645",156 although he was not sworn in until 30. January, 1649.¹⁵⁷ Similar conflict exists over the date of his exit from the chapter. Hersche records his exit in 1665, ¹⁵⁸ but he appears in the Acta as late as 19. July, 1670.¹⁵⁹ The Ordo Canonicorum of 1676 does not list him, although only 14 names are given.¹⁶⁰

23 Korff gnt. Schmising, Johann Adolf von

Johann Adolf belonged to a prominent Catholic family of the County of Ravensberg, being a son of Heinrich v. Korff-Schmising zu Tatenhausen and Sibylle v. Wendt.¹⁶¹ His uncle, Caspar, had also been a member of the Minden chapter until his death in 1645. Kohl records that he was eighteen years old when he entered the Collegium Germanicum on 8. November, 1649.162 He had become DH in Minden earlier that same year.163 He also became DH in Münster¹⁶⁴ and Propst zu St. Mauritz at Münster.¹⁶⁵ Johann Adolf died on 3. August, 1678.166

24 Cappel, Jobst Arnold von

This DH was a son of Jobst Wilhelm v. Cappel (Kappel) zu Wallenbrück, on the border between Osnabrück and Ravensberg, and Anne Elisabeth v. d. Lippe,167 and uncle of Simon Hemar (68). He may be identical with the Arnold v. Cappel recorded by Horst as lord of Wallenbrück and Warmenau from 1664 to 1667.¹⁶⁸ A Catholic, Cappel obtained a prebend in Minden on 3. April, 1649,¹⁶⁹ and was also DH in Osnabrück.¹⁷⁰ He ist listed in the Ordo Canonicorum for 1676,¹⁷¹ and died on 1. November, 1679.¹⁷²

25 Velen, Dietrich Anton von

Given by Culemann as Heinrich Dietrich Anton,¹⁷³ he was a son of Dietrich v. Vehlen zu Velen, Droste v. d. Emsland, and Catharine Sophia v. Wendt.¹⁷⁴ Dietrich Anton was born on 29. September, 1647, and died on 5. October, 1700.¹⁷⁵ He was sworn in at Minden on 6. June, 1664, ¹⁷⁶ and emancipated on 30. December, 1678.¹⁷⁷ Although two Aufschwörungstafeln are preserved in the archives,¹⁷⁸ there is no explanation in the Acta for this phenomenon, and no reason to believe that he was sworn in twice. Velen was also DH in Münster,¹⁷⁹ where he became Vicedominus and DP.¹⁸⁰ He was succeeded in Minden by Ferdinand v. Raesfeld (52).¹⁸¹

26 Nehem, Dietrich Heinrich von

A son of Hermann v. Nehem zu Sondermühlen and Barbara Catharine v. Korff-Schmising,¹⁸² Dietrich Heinrich was a nephew of Johann Eberhard (11), and uncle of Matthias Christoph Anton (42), Hermann Dietrich (44), and Otto Heinrich (56). He obtained a prebend in Minden on 30. June, 1664,¹⁸³ and was also DH in Osnabrück.¹⁸⁴ Nehem died in 1691,¹⁸⁵ and was succeeded by his nephew Hermann Dietrich.¹⁸⁶

27 Oer, Otto Heinrich von

Otto Heinrich was a son of Eberhard Georg v. Oer (Ohr) zu Bruche in the Bishopric of Osnabrück and Anne Sophia v. Oye.¹⁸⁷ He entered the Minden chapter as a protestant DH, and was emancipated in 1668.¹⁸⁸ He also obtained one of the three protestant positions in the chapter at Osnabrück.¹⁸⁹ In 1687, however, Oer converted to Catholicism, and resigned his two Protestant prebends,¹⁹⁰ obtaining Catholic prebends in Osnabrück and Paderborn in 1688.¹⁹¹ He died on 7. August, 1692, at the age of 52.¹⁹²

28 Aschebrock, Jobst Walter von

There is no AT for this DH, and he does not appear in Fahne. In the Acta and Hersche,¹⁹³ his family name is given as Ascheberg. Nonetheless, the given names Jobst and Walter make it probable that he was a son of Adolf Heinrich v. d. Dorneburg gnt. Aschebrock and Anne Sibylle v. Brabeck, in which case his paternal grandfather would be Jobst Wilhelm v. Aschebrock, and Walter would derive from his mother's family.¹⁹⁴ This would also make him a nephew of Franz Conrad (22). According to Hersche, he obtained a prebend in 1668.¹⁹⁵ The only reference to him in the Acta is his resignation on 10. October, 1668, when he was succeeded by Matthias Friedrich v. d. Recke. Elector Friedrich Wilhelm refused his consent to Aschebrock.¹⁹⁶

29 Recke, Matthias Friedrich von der

Born on 17. July, 1644,¹⁹⁷ Matthias Friedrich was a son of Johann v. d. Recke (Reck) zu Steinfurt and Mechtild Judith v. Galen zu Ermelinghoff.¹⁹⁸ He was presented with his prebend in Minden by Johann Heinrich v. Vincke as Turnarius,¹⁹⁹ and sworn in on 3. November, 1668, as successor to Jobst Walter v. Aschebrock (28).²⁰⁰ Culemann²⁰¹ and Hersche²⁰² record the presence of a brother, Wilhelm, from 1669 to 1675, and Keinemann²⁰³ and Kohl²⁰⁴ record another brother, Hermann, as DH in Minden "mindestens seit 1681", but I find no evidence in the archives to support these assertions. The only member

There are two AT in the archives,²⁰⁵ but, as noted in the case of Dietrich Anton v. Velen (25), this does not necessarily imply two persons. Hersche records Matthias Friedrich's admission in 1690, probably based on Culemann, but Culemann's date is florit, not admissus, and the Acta are clear for the admission of Matthias Friedrich in 1668. Recke was also DH in Münster,²⁰⁶ where he attained the dignity of DD, and Propst zu St. Mauritz.²⁰⁷ Keinemann records that he was also DH in Paderborn,²⁰⁸ but has probably confused him with Matthias Dietrich v. d. Recke zu Berge u. Mallinckrodt, DH in Münster, Paderborn, and Worms.²⁰⁹ Matthias Friedrich died on 3. February, 1701,²¹⁰ and was succeeded in his Mindener prebend by Maximilian Ferdinand Anton v. d. Horst (53).²¹¹

30 Schilder, Raban Wilhelm von

This son of Arnold v. Schilder zu Dreckburg and Catharine v. Galen was born on 9. October, 1649, and died on 22. February, 1699.²¹² As nephew of Christoph Bernhard and Heinrich v. Galen, he became the first incumbent of the first Galen Family Prebend in Minden.²¹³ He was presented by Goswin v. Droste-Vischering and Heinrich v. Galen, and gained possession on 7. January, 1669.²¹⁴ He was not emancipated until 6. December, 1686.²¹⁵ Raban Wilhelm was a nephew of Eberhard Adrian (14). He obtained a prebend in Münster,²¹⁶ and became Kellner and Cantor there, as well as Propst zu St. Martin in Münster and St. Victor in Dülmen.²¹⁷ He was succeeded in the Galen Family Prebend by Wilhelm Ferdinand v. Galen (50).²¹⁸

31 Wendt, Heinrich Wilhelm von

Heinrich Wilhelm was a son of Matthias v. Wendt zu Holtfeld and Mechtild v. Leerodt, and a brother of Johann Adrian (17).²¹⁹ Although Hersche gives his date of entrance into the Minden chapter as 1690,²²⁰ he is recorded in the Acta as participating in the election of Valcke as DD on 8. May, 1670.²²¹ This is not a misreading for his brother, as both are mentioned. He is also recorded in the Ordo Canonicorum of 1676.²²² and in the election of Albert Clamor v. d. Bussche as DD in 1686.²²³ Culemann lists him as DD,²²⁴ but this is a confusion with his brother. Heinrich Wilhelm was also DH in Hildesheim, Münster, and perhaps Speyer.²²⁵ Keinemann records that he was DH in Osnabrück,²²⁶ but I find no evidence in the Staatsarchiv Osnabrück to support this assertion. He died on 7. January, 1703,²²⁷ and was succeeded by Caspar Ernst Rotger v. Wrede (55).²²⁸

32 Korff, Heinrich Victor von

This DH was a son of the Protestant Eberhard Victor v. Korff zu Waghorst and Margarete Elisabeth v. Voss,²²⁹ and was born on 5. November, 1660.²³⁰ He was sworn in at Minden on 30. May, 1673, as successor to Caspar Adam v. Schele (6),²³¹ and emancipated on 28. February, 1684.²³² In 1705 he married Gertrude Maria Luise Christine v. Voss,²³³ his cousin. He succeeded Albert Clamor v. d. Bussche as DD in 1710.²³⁴ Although the Acta record his death on 25. May, 1713,²³⁵ Dungern gives 7. August, 1713.²³⁶

33 Loe, Matthias Balthasar von

This son of Degenhard Bertram v. Loe (Loh) zu Wissen in the Duchy of Cleves and Anne Franziska v. Nesselrode²³⁷ was born sometime after the marriage of his parents in 1644.²³⁸ He obtained collation for a prebend in Minden on 3. April, 1674,²³⁹ and was sworn in on 5. February, 1675.²⁴⁰ He left the chapter in 1690, when he was succeeded by Matthias Christoph Anton v. Nehem (42).²⁴¹

34 Neuhoff, Jacob Leopold von

Jacob Leopold was a son of Stephan v. Neuhoff zu Horstmar and Dorothea Elisabeth v. Wenge,²⁴² and grand-nephew of Johann Georg (1). His brother, Stephan Dietrich, was married in 1685 to Sophia Elisabeth v. Galen, daughter of the Droste zu Vechta Heinrich v. Galen,²⁴³ which confirmed the close association indicated by Jacob Leopold being granted possession of the second Galen Family Prebend in Minden.²⁴⁴ He was sworn in on 7. June, 1677,²⁴⁵ and emancipated on 22. April, 1686.²⁴⁶ After his death in 1693,²⁴⁷ he was succeeded by Wilhelm Goswin Anton v. Galen (46).²⁴⁸

35 Vincke, Johann Dietrich von

This nephew of Johann Heinrich (5) was a son of the Protestant Idel Jobst v. Vincke zu Ostenwalde and Anne Elisabeth v. d. Recke zu Stockhausen,²⁴⁹ and an uncle of Johann Friedrich Georg (66). He was sworn in on 26. January, 1678, and emancipated in the following year.²⁵⁰ Johann Dietrich died on 26. February, 1714, as Senior and Gross-Vogt of the chapter.²⁵¹

36 Valcke, Michael Gottfried von

Michael Gottfried was a son of Stephan v. Valcke zu Rockel and Elisabeth Anne v. Rheden,²⁵² nephew of the DP Jobst v. Valcke (16), and brother of Christoph Bernhard (45).

He obtained possession of his prebend on 1. November, 1678.²⁵³ Although Culemann records his emancipation in 1684,²⁵⁴ the Acta gives 19. January, 1688.²⁵⁵ Michael Gottfried obtained the dignity of Scholasticus,²⁵⁶ and died on 9. November, 1708,²⁵⁷ being succeeded by Johann Philipp v. Venningen (60).²⁵⁸

37 Münchhausen, Christoph Ludolf von

This Protestant DH was a son of Borries v. Münchhausen zu Lauenau and Sophia Magdalena v. Hammerstein,²⁵⁹ and brother of Borries (39). He was sworn in on 31. March, 1680,²⁶⁰ and emancipated on 10. April of that same year.²⁶¹ He obtained the dignity of Scholasticus²⁶² before his death in June, 1700, when he was succeeded by Christian Philipp v. Schele (51).²⁶³

38 Bussche, Albert Clamor von dem

Albert Clamor was a son of the Protestant Hilmer v. d. Bussche zu Haddenhausen and Lucie v. Steding,²⁶⁴ and uncle of Hilmer Albrecht (48). He was born on 28. January, 1653, and died on 1. March, 1710.²⁶⁵ He obtained possession of a prebend in Minden on 29. August, 1683,²⁶⁶ and was elected DD on 6. December, 1686.²⁶⁷ He was also Probst zu Levern,²⁶⁸ and was succeeded in Minden by Arnold Heinrich v. Treskow (61).²⁶⁹

39 Münchhausen, Borries (Liborius) von

This brother of Christoph Ludolf (37) was a son of Borries v. Münchhausen zu Lauenau and Sophia Magdalena v. Hammerstein,²⁷⁰ and a subject of the Elector of Hanover. He was sworn in at Minden on 20. February, 1687,²⁷¹ and emancipated on 24. March of that year.²⁷² Borries died on 2. January, 1721,²⁷³ and was succeeded by Georg Ludwig v. Bar (71).²⁷⁴

40 Horst, Adrian Christian Wolfgang von der

This son of the Droste zu Vlotho Arnold Christoph v. d. Horst zu Hellenbroich and Helena Theodora v. Wulff gnt. Lüdinghausen²⁷⁵ is also called Adam by Robens.²⁷⁶ He was a nephew of Johann (12) and brother of Maximilian Ferdinand Anton (53). He was sworn in on 15. December, 1687, as successor to Jobst Heinrich v. Korff (18),²⁷⁷ and emancipated on 23. May, 1689.²⁷⁸ Horst succeeded Heinrich Wilhelm v. Wendt as DP in 1703,²⁷⁹ and was also DH in Hildesheim.²⁸⁰ Following his death on 17. June, 1712,²⁸¹ he was succeeded by Adolf Hermann Philipp v. Hanxleden (64).²⁸²

41 Bussche, Christoph von dem

This first incumbent of the Bussche Family Prebend²⁸³ was the eldest surviving son of Clamor Eberhard v. d. Bussche zu Hünefeld and Elisabeth v. Görne.²⁸⁴ As such, he was Erbherr zu Hünefeld and Buddemühlen, and he founded a Fideicommiss with 100,000 Thaler and the Hünefelder Majorat.²⁸⁵ Christoph was born on 8. June, 1643, and died on 14. January, 1695.²⁸⁶ He was sworn in at Minden on 7. June, 1689,²⁸⁷ and emancipated on 12. December of that year.²⁸⁸ His successor in the Bussche Family Prebend was Hilmer Albrecht v. d. Bussche zu Haddenhausen (48).289

42 Nehem, Matthias Christoph Anton von

This son of Friedrich v. Nehem zu Sondermühlen and Ludowika Margarete v. d. Horst²⁹⁰ was baptized on 23. October, 1678.²⁹¹ He was a brother of Hermann Dietrich (44) and Otto Heinrich (56), and nephew of Dietrich Heinrich v. Nehem (26), Adrian Christian Wolfgang v. d. Horst (40), and Maximilian Ferdinand Anton v. d. Horst (53). He obtained possession of a prebend in Minden on 6. November, 1691,²⁹² as the successor of Matthias Balthasar v. Loe (33).²⁹³ He was also DH in Osnabrück.²⁹⁴ Upon the death of his father in 1696, Matthias became Herr zu Sondermühlen and other properties in the Bishopric of Osnabrück, and resigned in Minden on 13. July, 1703,²⁹⁵ in favor of his brother Otto Heinrich (56).²⁹⁶ In 1704 he married Agatha Juliana v. Brencken, and died in 1720.²⁹⁷

43 Dinklage, Eberhard Hermann Jobst von

In addition to serving as a member of the cathedral chapter at Minden, this Protestant DH was also the Stammherr of the Dinklages of Schulenburg in the Bishopric of Osnabrück. He was born on 9. April, 1680,²⁹⁸ the son of Gerhard Daniel v. Dinklage zu Schulenburg and Mechtild Christine v. Schele.²⁹⁹ Eberhard Hermann obtained a prebend in Minden on 23. June, 1692,³⁰⁰ and was emancipated on 29. April, 1700,³⁰¹ as the successor of his great-uncle Jobst Dietrich (15).³⁰² He married Charlotte Amalia v. Witzleben, and became Senior of the Ritterschaft in Osnabrück and Senior of the Minden chapter.³⁰³ Although the Addenda in Culemann records his death on 26. Febrary, 1756,³⁰⁴ the year must be in error, as he was succeeded in Minden by Eberhard Friedrich v. d. Recke (91) in 1755.305

44 Nehem, Hermann Dietrich von

The second son of Friedrich v. Nehem zu Sundermühlen and Ludowika Margarete v. d. Horst,³⁰⁶ Hermann Dietrich was born on 6. September, 1679.³⁰⁷ He succeeded his uncle Dietrich Heinrich (26) in a prebend in Minden,³⁰⁸ where he was sworn in on 23. June, 1692,

the same day as Eberhard Hermann Jobst v. Dinklage,³⁰⁹ After a five year vacancy, he succeeded Heinrich Friedrich Wolfgang v. Boeselager (62) as DP in 1721.³¹⁰ Nehem was also DH in Osnabrück.³¹¹ He died on 22. March, 1734,³¹² and was succeeded in Minden by Hermann Caspar v. Hanxleden (80).³¹³

45 Valcke, Christoph Bernhard Johann von

Like his brother Michael Gottfried (36), Christoph Bernhard was a nephew of the DP Jobst v. Valcke, and son of Stephan v. Valcke zu Rockel and Elisabeth Anne v. Rheden.³¹⁴ His uncle resigned in his favor on 28. August, 1693,³¹⁵ and he was sworn in on 5. October of that year.³¹⁶ After only ten years, Christoph Bernhard died on 7. January, 1703,³¹⁷ and was succeeded by Jobst Heinrich v. Oer (54).³¹⁸

46 Galen, Wilhelm Goswin Anton von

Born on 1. October, 1678,³¹⁹ Wilhelm Goswin Anton was the eldest son of the Erbkämmerer von Münster Franz Wilhelm v. Galen and Ursula Helena v. Plettenberg.³²⁰ He was nephew of Ferdinand Benedict (67) and Karl Anton (83), brother of Wilhelm Ferdinand (50) and Friedrich Christian (49), and uncle of Clemens August (74) and Ferdinand Karl (101). On 18. July, 1693, he received from his father collation to the second Galen Family Prebend, vacated by the death of Jacob Leopold v. Neuhoff (34), and was sworn in two days later.³²¹ On 3. May, 1697, he resigned, ³²² and was succeeded by his younger brother Friedrich Christian (49).³²³ As heir presumptive to the family patrimony, on 6. September, 1704, he married Maria Agnes v. Ketteler zu Sythen,³²⁴ but he died on 11. September, 1710,³²⁵ leaving only one daughter, Anne Helena Maria Antonetta, the mother of the future statesman Franz v. Fürstenberg.

47 Westphalen, Heinrich Dietrich von

This scion of the Paderborn nobility was a son of Wilhelm v. Westphalen zu Fürstenberg and Catharine Sophia v. Brencken,³²⁶ born on 28. December, 1675.³²⁷ He succeeded Johann Adrian v. Wendt (17) in Minden³²⁸ by collation of Heinrich Wilhelm v. Wendt acting as Turnarius on 28. December, 1694,³²⁹ and was sworn in on 7. March, 1695.³³⁰ His emancipation took place on 8. April, 1696.³³¹ Heinrich Dietrich was also DH in Paderborn and Propst zu St. Johann in Minden.³³² There ist a seven year gap between the date of his death as reported by Michels, 4. April, 1720,³³³ and the collation of his successor in Minden, Franz Arnold v. Wendt (72).³³⁴

48 Bussche, Hilmer Albrecht von dem

This second incumbent of the Bussche Family Prebend succeeded Christoph v. d. Bussche (41)³³⁵ and was sworn in on 14. March, 1695.³³⁶ He was a son of Johann Wilhelm v. d. Bussche zu Haddenhausen and Margarete Elisabeth v. Ledebur,³³⁷ and nephew of Albert Clamor (38). Hilmer Albrecht was born on 27. October, 1689, and died on 3. August, 1726.³³⁸ He became Thes. of the Minden chapter and Mindener Geheimrat.³³⁹ In 1718, he married Anne Dorothea v. Vincke zu Ostenwalde, and was the father of the DH Jobst Heinrich Wilhelm (86).³⁴⁰ He was succeeded in the Bussche Family Prebend by Johann Georg v. d. Bussche zu Hünefeld (78).³⁴¹

49 Galen, Friedrich Christian Joseph von

One of the best endowed DHH of the period, Fritz v. Galen held prebends in Münster,³⁴² Paderborn,³⁴³ Osnabrück,³⁴⁴ Hildesheim,³⁴⁵ and Worms³⁴⁶ in addition to that in Minden. A son of the Erbkämmerer Franz Wilhelm v. Galen and Ursula Helena v. Plettenberg,³⁴⁷ he succeeded his brother Wilhelm Goswin Anton (46) in the second Galen Family Prebend in Minden, receiving collation from his father on 5. August, 1697,³⁴⁸ possession on 19. August of that year,³⁴⁹ and emancipation on 21. March, 1729.³⁵⁰ Friedrich Christian Joseph was born on 27. March, 1689, and died on 15. February, 1748.³⁵¹ He was succeeded in Minden by Lothar Franz v. Galen zu Ermelinghof (84).³⁵²

50 Galen, Wilhelm Ferdinand von

The youngest son of the Erbkämmerer Franz Wilhelm v. Galen and Ursula Helena v. Plettenberg,³⁵³ Wilhelm Ferdinand was born on 1./2. November, 1690, and died on 28. December, 1769.³⁵⁴ He received collation to the first Galen Family Prebend in Minden from his father on 21. April, 1699, following the death of Raban Wilhelm v. Schilder (30), and was sworn in on 8. July, 1699, and emancipated on 3. August, 1711.³⁵⁵ After the death of his brother Wilhelm Goswin Anton (46), Wilhelm Ferdinand was chosen to succeed to the family patrimony. He resigned in Minden on 31. January, 1716,³⁵⁶ and was succeeded there by his uncle Ferdinand Benedict (67).³⁵⁷ On 2. September, 1719, he married Maria Henriette v. Fürstenberg,⁵⁵⁸ by whom he was the father of the DH Clemens August (74), and, after her death, on 10. February, 1748, he married Sophia Luise v. Merveldt,³⁵⁹ by whom he was the father of the DH Ferdinand Karl (101).

51 Schele, Christian Philipp von

This member of a Protestant family of the Bishopric of Osnabrück was a son of Balthasar Sweder v. Schele zu Schelenburg and Clara Dorothea v. Haus,³⁶⁰ and a nephew of Caspar Adam (6). He received collation to the prebend vacated by Christoph Ludolf v. Münchhausen (37) from Dietrich Anton v. Velen as Turnarius, and was sworn in on 7. July, 1700.³⁶¹ Schele was also DH in Osnabrück, where he held one of the three Protestant prebends.³⁶² He resigned in Minden on 15. June, 1707, in favor of Alexander v. Hammerstein (58),³⁶³ and died on 1. December of that year.³⁶⁴

52 Raesfeld, Ferdinand von

This DH was born 1. May, 1680,³⁶⁵ the son of Johann Adolf v. Raesfeld zu Ostendorf and Anne Maria v. Galen.³⁶⁶ He was a nephew of Ferdinand Benedict (67) and Karl Anton (83) v. Galen. He received collation from Matthias Friedrich v. d. Recke as Turnarius to succeed Dietrich Anton v. Velen (25) on 5. October, 1700,³⁶⁷ and was sworsn in on 17. January, 1701,³⁶⁸ and emancipated on 27. January, 1703.³⁶⁹ Raesfeld resigned his prebend on 9. June, 1706, and was succeeded by Jobst Caspar v. Vincke (57).³⁷⁰ The absence of this person from the Raesfeld genealogies given by Fahne³⁷¹ and Stammtafeln³⁷² is worthy of note, inasmuch as the AT is clear about his ancestry. Is it possible that this Ferdinand is identical with the Christoph Heinrich v. Raesfeld who married in 1708 and died in 1729?

53 Horst, Maximilian Ferdinand Anton von der

A younger son of Arnold Christoph v. d. Horst zu Hellenbroich and Helena Theodora v. Wulff gnt. Lüdinghausen,³⁷³ Max was a nephew of Johann (12) and brother of Adrian Christian Wolfgang (40). He was born on 14. April, 1669,³⁷⁴ and received collation on 21. February, 1701, to the prebend vacated by the death of Matthias Friedrich v. d. Recke (29) from Heinrich Victor v. Korff as Turnarius.³⁷⁵ He was sworn in on 4. April, 1701,³⁷⁶ and emancipated a month later on 2. May.³⁷⁷ He also obtained a prebend at Paderborn.³⁷⁸ Horst resigned his Minden prebend in June, 1707,³⁷⁹ where he was succeeded by Heinrich Friedrich Wolfgang v. Boeselager (62).³⁸⁰ In 1708 he married Anne Sophia Wilhelmine v. Lüninck, heiress of Cappel, and then pursued a successful military career, rising to the rank of Lieutenant General before his death in 1739.

54 Oer, Jobst Heinrich von

Baptized on 13. August, 1673,³⁸¹ Jobst Heinrich was a son of Jobst Caspar v. Oer (Ohr) zu Nottbeck, who converted to Catholicism in 1696, and Elisabeth Margarete v. Billerbeck.³⁸² On 25. May, 1703, he presented a collation from Johann Dietrich v. Vincke as Turnarius for the prebend vacated by the death of Christoph Bernhard v. Valcke (45),³⁸³ and was

sworn in on 29. May.³⁸⁴ His emancipation took place several weeks later on 9. July, 1703.³⁸⁵ Oer is recorded as Sch. in 1713.³⁸⁶ He died in 1751,³⁸⁷ and was succeeded by Damian Wilhelm Caspar, Forstmeister v. Gelnhausen (87).³⁸⁸

55 Wrede, Caspar Ernst Rotger von

This child of the Duchy of Westphalia was a son of Johann Ernst v. Wrede zu Amecke and Josine Elisabeth v. Asbeck,³⁸⁹ and grandnephew of Heinrich Alexander (9). He was baptized on 17. January, 1679,³⁹⁰ and died on 9. December, 1707.³⁹¹ In Minden he succeeded to the prebend vacated by the death of Heinrich Wilhelm v. Wendt (31),³⁹² and was sworn in on 28. June, 1703.³⁹³ His emancipation took place the following month, on 3. July.³⁹⁴ Wrede was succeeded by Karl Ferdinand v. Venningen (59).³⁹⁵

56 Nehem, Otto Heinrich Ferdinand Ludwig von

The third son of Friedrich v. Nehem zu Sondermühlen and Ludowika Margarete v. d. Horst³⁹⁶ to hold a prebend in Minden, Otto Heinrich was a brother of Matthias Christoph Anton (42) and Hermann Dietrich (44). He succeeded to the prebend vacated by his brother Matthias,³⁹⁷ and was sworn in on 28. April, 1704.³⁹⁸ His emancipation was held on 20. October, 1710.³⁹⁹ Otto Heinrich was also DH in Hildesheim.⁴⁰⁰ He died in 1725,⁴⁰¹ and was succeeded by Anton Ludwig August v. Dalwigk (73).⁴⁰²

57 Vincke, Jobst Caspar von

A member of the Catholic branch of this family, Jobst Caspar was a son of Heinrich Rudolf Hilmer v. Vincke zu Kilver and Margarete Eva v. Ketteler.⁴⁰³ He was sworn in on 11. September, 1706,⁴⁰⁴ as the successor of Ferdinand v. Raesfeld (52).⁴⁰⁵ He resigned on 4. October, 1720, in favor of his cousin, Friedrich Christian v. Ketteler (70),⁴⁰⁶ and later married Mechtild Maria Voigt von Elspe, continuing the line of the Vinckes zu Kilver.

58 Hammerstein, Alexander von

From an originally Calenberger family introduced into the Bishopric of Osnabrück by Ernst August, Elector of Hanover, Alexander was born on 23. December, 1686, the son of Christian Günther v. Hammerstein zu Loxten and Gertrude Agnes Schenk v. Winterstedt.⁴⁰⁷ He succeeded to a Protestant prebend left vacant by the resignation of Christian Philipp v. Schele (51),⁴⁰⁸ and was sworn in on 13. July, 1707,⁴⁰⁹ with his emancipation taking place a month later on 16. August.⁴¹⁰ On 19. July, 1713, he was elected DD in

succession to Heinrich Victor v. Korff (32).411 Hammerstein married three times, but left no issue.⁴¹² He died on 1. February, 1755,⁴¹³ and was succeeded by Heinrich Plato v. Ledebur (90).414

59 Venningen, Karl Ferdinand von

The son of the Prussian general Johann Augustin v. Venningen zu Neidenstein and Agnes Anne v. Chalon gnt. Gehlen,⁴¹⁵ Karl Ferdinand was baptized on 25. February, 1693.⁴¹⁶ He obtained collation from Sch. Valcke as Turnarius⁴¹⁷ upon the death of Caspar Ernst Rotger v. Wrede (55),⁴¹⁸ and was sworn in on 14. February, 1708.⁴¹⁹ His emancipation took place on 20. January, 1713.⁴²⁰ Venningen was also DH in Osnabrück.⁴²¹ He resigned his prebend on 12. November, 1719,⁴²² and was succeeded by Ernst Friedrich v. Ascheberg (69).⁴²³ He died in 1731.424

60 Venningen, Johann Philipp von

Brother of Karl Ferdinand (59), Johann Philipp received his prebend at the request of the King of Prussia in recognition of the services of his father, Johann Augustin v. Vennin-gen.⁴²⁵ He was sworn in on 30. November, 1709,⁴²⁶ as the successor of Michael Gottfried v. Valcke (36),⁴²⁷ but only a year and a half later, on 23. April, 1711,⁴²⁸ he resigned in favor of Adolf Heinrich v. Droste-Vischering (63).429

61 Treskow, Arnold Heinrich von

This son of a servant of the Prussian crown, Johann Sigismund v. Treskow, and Anne v. Katte,⁴³⁰ was born on 8. November, 1687.⁴³¹ He received the royal collation on 8. March, 1710, for the position vacated by the death of Albert Clamor v. d. Bussche,⁴³² and was sworn in on 2. June, 1710.433 Arnold Heinrich was also Propst zu Levern and Prussian Geheimrat.⁴³⁴ He died in 1729,⁴³⁵ and was succeeded by Wilhelm Christian v. d. Recke $(75).^{436}$

62 Boeselager, Heinrich Friedrich Wolfgang von

The first member of his familiy to obtain a prebend in a Westphalian cathedral chapter, Boeselager was born on 30. September, 1687,⁴³⁷ the son of Wolfgang v. Boeselager zu

Eggermühlen, in the Bishopric of Osnabrück, and Brigitta Theodora Elisabeth v. Korff.⁴³⁸ He obtained collation from Albert Clamor v. d. Bussche on 10. August, 1708, for the prebend vacated by the resignation of Maximilian Ferdinand Anton v. d. Horst, 439 but was not sworn in until 8. May, 1711.440 In the following year, he received royal appointment as the successor of Adrian Christian Wolfgang v. d. Horst (40) in the Domprobstei.441 Boeselager died on 26. August, 1716⁴⁴² his prebend going to Simon Hemar v. Cappel (68).⁴⁴³

63 Droste zu Vischering, Adolf Heinrich von

Son of the Münster Erbdrost Christoph Heidenreich v. Droste-Vischering and Brigitta Clara v. Galen,444 and nephew of Christoph Bernhard v. Galen, Adolf Heinrich was baptized on 13. December, 1699,445 along with his twin brother Heidenreich Matthias. Johann Philipp v. Venningen (60) resigned his prebend in Minden in favor of Adolf Heinrich,⁴⁴⁶ who was sworn in on 1. June, 1711.⁴⁴⁷ Droste also held prebends in Münster and Osnabrück.448 He resigned his Minden prebend in February, 1729,449 and was succeeded by Friedrich Bernhard v. Wrede (77).450

64 Hanxleden, Adolf Hermann Philipp von

This native of the Principality of Minden was a son of Günther Egon v. Hanxleden zu Eickel and Clara Maria v. Westerholt,⁴⁵¹ and brother of Franz Christoph (79) and Hermann Caspar (80). He received collation on 15. August, 1712, from Borries v. Münchhausen as Turnarius to the prebend formerly held by Adrian Christian Wolfgang v. d. Horst (40),⁴⁵² and was sworn in on 13. September of that year.⁴⁵³ On 13. October, 1733, he resigned in favor of his brother Franz Christoph,⁴⁵⁴ and on 19. January, 1734, he married Maria Josepha Franziska v. Korff,⁴⁵⁵ continuing the line of the Hanxledens zu Eickel.

65 Ledebur, Heinrich von

Although Fahne says Ledebur was born in 1691,⁴⁵⁶ the Acta record his baptism on 11. August, 1690.457 This Protestant native of the County of Ravensberg was a son of Heinrich v. Ledebur zu Mühlenburg and Rosamunde Lucretia v. Alvensleben.⁴⁵⁸ He obtained possession of a Minden prebend on 14. December, 1713,⁴⁵⁹ and was emancipated on 9. January, 1714.460 Heinrich succeeded his father as Herr zu Ober- und Nieder-Mühlenburg, and became Droste zu Ravensberg.⁴⁶¹ He married in 1730 Amalia Elisabeth v. d. Bussche, and in 1738 Adelheid Johanna Gräfin v. d. Schulenburg, by whom he was the

father of Christian Heinrich Ernst (94).⁴⁶² Following his death on 6. August, 1751,⁴⁶³ he was succeeded in Minden by Jobst Heinrich Wilhelm v. d. Bussche (86).⁴⁶⁴

66 Vincke, Johann Friedrich Georg von

This DH was a son of Idel Jobst v. Vincke zu Ostenwalde and Agnes Elisabeth v. Steding,⁴⁶⁵ nephew of Johann Dietrich (35), and uncle of Ernst Idel Jobst (95). He was baptized on 23. March, 1682,⁴⁶⁶ and died on 15. June, 1756.⁴⁶⁷ He obtained his prebend in Minden on 18. April, 1714,⁴⁶⁸ also becoming Gross-Vogt and Probst zu St. Marien in Minden.⁴⁶⁹ He married Wilhelmine Elisabeth v. Steding.⁴⁷⁰ In Minden, he was succeeded by Karl Abraham v. Bottlenberg gnt. Kessel (93).⁴⁷¹

67 Galen, Ferdinand Benedict von

Ferdinand Benedict was born on 30. August, 1665,⁴⁷² the son of the Droste zu Vechta Heinrich v. Galen and his second wife, Anne Elisabeth v. d. Recke.⁴⁷³ He succeeded his nephew Wilhelm Ferdinand (50) in the first Galen Family Prebend in Minden, obtaining possession on 26. May, 1716, and emancipation on 10. June of that same year.⁴⁷⁴ He was also DH in Münster, Onabrück, and Mainz.⁴⁷⁵ Ferdinand Benedict died on 24. October, 1727,⁴⁷⁶ and was succeeded in Minden by Clemens August v. Galen (74).⁴⁷⁷

68 Cappel, Simon Hemar von

Simon Ĥemar was the son of Bernhard Wilhelm v. Cappel zu Huntemühlen and Dorothea v. Ketteler,⁴⁷⁸ and nephew of Jobst Arnold (24). He was baptized on 24. June, 1686.⁴⁷⁹ Cappel received collation from Eberhard Hermann Jobst v. Dinklage as Turnarius to succeed Heinrich Friedrich Wolfgang v. Boeselager (62), and was sworn in on 10. October, 1716.⁴⁸⁰ His emancipation took place on 2. April, 1718.⁴⁸¹ Cappel was also DH in Mainz,⁴⁸² and died on 23. June 1731.⁴⁸³

69 Ascheberg, Ernst Friedrich von

Ascheberg was born on 10. September, 1702, and died on 22. September, 1762.⁴⁸⁴ He was a son of Johann Matthias v. Ascheberg zu Venne and Catharine Agnes Elisabeth v. Lipperheide.⁴⁸⁵ The genealogy given by Fahne⁴⁸⁶ skips a generation, as compared with that preserved in the AT of this DH and his brother Karl Heinrich (76). Ernst Friedrich received royal collation to the prebend vacated by the resignation of Karl Ferdinand v. Venningen

(59),⁴⁸⁷ and was sworn in on 15. June, 1720.⁴⁸⁸ He was also DH in Münster.⁴⁸⁹ On 1. November, 1729, Ernst Friedrich resigned his prebend in favor of his brother Karl Heinrich (76),490 and then married Sophia Ursula v. Droste zu Füchten.

70 Ketteler, Friedrich Christian von

This DH ist not to be confused with the Friedrich Christian v. Ketteler zu Harkotten who was Sch. in Münster, who was a son of Goswin Caspar v. Ketteler. The DH in Minden was a son of Johann Conrad v. Ketteler, Droste zu Sassenberg, and Anne Helena v. Hanxleden.⁴⁹¹ He was baptized on 24. April, 1689,⁴⁹² and died on 5. April, 1740.⁴⁹³ Ketteler's cousin, Jobst Caspar v. Vincke (57), resigned in his favor, 494 with his swearing in taking place on 21. January, 1721, and his emancipation a few weeks later on 18. February.⁴⁹⁵ Following his death, Ketteler was succeeded by Adolf Franz v. Dalberg (85).496

71 Bar, Georg Ludwig von

Son of the Erblanddrost of the Bishopric of Osnabrück Heinrich Sigismund Graf v. Bar zu Barenaue and Anne Agnes v. Chalon gnt. Gehlen,⁴⁹⁷ Georg Ludwig was baptized on 10. January, 1701.⁴⁹⁸ He received collation from Hermann Dietrich v. Nehem as Turnarius for the prebend formerly held by Borries v. Münchhausen (39),⁴⁹⁹ and was sworn in on 22. July, 1721.⁵⁰⁰ In 1722 he married Johanna Taets van Amerongen.⁵⁰¹ Upon the death of his brother Nikolaus Christian in 1765, he succeeded to the family patrimony, and is the ancestor of the later Erblanddrosten.⁵⁰² Georg Ludwig was also Propst zu Levern.⁵⁰³ He died on 6. August, 1767,⁵⁰⁴ and was succeeded in Minden by Philipp Georg Wilhelm v. Cornberg (102).505

72 Wendt, Franz Arnold von

This son of Franz Wilhelm v. Wendt zu Holtfeld and Agatha Catharine v. Westphalen⁵⁰⁶ was baptized on 26. April, 1712.⁵⁰⁷ He had many connections in the chapter at Minden, being grand-nephew of Johann Adrian (17) and Heinrich Wilhelm (31), nephew of Heinrich Dietrich v. Westphalen (47), and brother of Wilhelm Adolf (82). Franz Arnold succeeded his uncle Westphalen, apparently after a seven year hiatus, in a prebend at Minden, being sworn in on 26. July, 1727, ⁵⁰⁸ and emancipated on 20. October, 1733.⁵⁰⁹ He resigned in 1744,⁵¹⁰ and was followed by his brother Wilhelm Adolf (82).⁵¹¹ In 1745 he married Theresa Franziska v. Droste zu Erwitte.⁵¹² There is some controversy concerning the date of his death, with Horst giving 1768,⁵¹³ but Fahne stating that he was Senior der Familie from 1749 to 1777.514

73 Dalwigk, Anton Ludwig August Franz von

Dalwigk was sworn in on 26. August, 1727,⁵¹⁵ as the successor of Otto Heinrich v. Nehem (56).⁵¹⁶ He was the son of Johann Georg Friedrich v. Dalwigk zum Sandt and Lucie Dorothea v. Calenberg.⁵¹⁷ His emancipation took place on 23. August, 1729,⁵¹⁸ after which he eventually attained the dignity of Sch.⁵¹⁹ This DH is identical with the Anton Adolf Ludwig v. Dalwigk who was DH in Hildesheim from 1763 to 1773.520 He died on 22. November, 1777,⁵²¹ and was succeeded by Valentin Ernst Ludwig v. d. Recke (104).⁵²²

74 Galen, Clemens August Ferdinand von Born 14. June, 1720,⁵²³ the only son of the Erbkämmerer Wilhelm Ferdinand v. Galen by his first wife, Maria Henriette v. Fürstenberg, 524 Clemens August received collation to the first Galen Family Prebend from his father on 19. January, 1728, following the death of Ferdinand Benedict v. Galen (67).⁵²⁵ He was sworn in on 16. February, 1728, while still seven years old.⁵²⁶ He was also DH in Münster,⁵²⁷ but not in Osnabrück, as reported by Culemann.⁵²⁸ who evidently confuses him with his half-brother Clemens August Joseph, who was DH in Osnabrück 1756-70.529 Clemens August Ferdinand died on 20. October, 1747,530 and was succeeded by Karl Anton v. Galen (83).531

75 Recke, Wilhelm Christian von der

Eldest son of Matthias Hilmer v. d. Recke zu Stockhausen in the Principality of Minden and Lewina v. Hammerstein,⁵³² Wilhelm was born in 1707,⁵³³ and succeeded to the family patrimony while still a minor. He obtained a prebend in Minden on 4. October, 1729534 where he became Thes. and Archdeacon of Lübbecke.⁵³⁵ Recke was emancipated on 27. February, 1730.⁵³⁶ He married first in 1734, but his wife died six months later, and he did not remarry until his union with Sophia Dorothea Friederike v. Rochow in 1742.537 From this marriage came the DHH Eberhard Friedrich (91) and Valentin Ernst (104). An active member of the chapter and the local administration, Recke was a Geheimer Regierungs-und Landrat.⁵³⁸ He died on 18. September, 1764,⁵³⁹ and was succeeded by Friedrich August v. Kerssenbrock (99).540

76 Ascheberg, Karl Heinrich Anton von

Karl Heinrich was baptized on 31. July, 1718,⁵⁴¹ the son of Johann Matthias v. Ascheberg zu Venne and Catharine Agnes Elisabeth v. Lipperheide.⁵⁴² He succeeded his brother Ernst Friedrich (69) as DH in both Minden⁵⁴³ and Münster.⁵⁴⁴ Sworn in on 5. December, 1729,⁵⁴⁵

August, 1749.⁵⁴⁶ He was a priest.⁵⁴⁷ Following his death on 8. July, 1760,⁵⁴⁸ he was succeeded by Karl Joseph Huber von Maur (98).⁵⁴⁹

77 Wrede, Friedrich Bernhard von

This son of Jobst Bernhard v. Wrede zu Melschede and Anne Sabine v. d. Heese⁵⁵⁰ succeeded to the prebend vacated by the resignation of Adolf Heinrich v. Droste-Vischering (63).⁵⁵¹ His swearing in took place on 29. December, 1729,⁵⁵² and his emancipation on 1. November, 1730.⁵⁵³ He was born on 14. March, 1704⁵⁵⁴ and died on 25. June, 1764,⁵⁵⁵ after which his prebend was held by Leopold Ludwig August v. Hörde (100).⁵⁵⁶

78 Bussche, Johann Georg von dem

This third incumbent of the Bussche Family Prebend succeeded Hilmer Albrecht v. d. Bussche (48) by collation of his brother Johann Friedrich on 26. August, 1726.⁵⁵⁷ Nonetheless, he was not sworn in until 12. January, 1730.⁵⁵⁸ He was the son of Clamor Albrecht v. d. Bussche zu Hünefeld and Agnes Sophia v. Hammerstein,⁵⁵⁹ and uncle of Christian August Clamor (97) and Georg Wilhelm Werner (89). Born on 17. November, 1713,⁵⁶⁰ he died on 17. May, 1753.⁵⁶¹ His emancipation was held on 18. July, 1740.⁵⁶²

79 Hanxleden, Franz Christoph von

Franz Christoph succeeded his brother Adolf Hermann Philipp (64) in a prebend in Minden,⁵⁶³ being sworn in on 9. February, 1734,⁵⁶⁴ and emancipated on 30. June, of that year.⁵⁶⁵ He was the son of Günther Egon v. Hanxleden zu Eickel and Clara Maria v. Westerholt,⁵⁶⁶ was born on 4. October, 1702,⁵⁶⁷ and died on 15. May, 1770.⁵⁶⁸ Franz Christoph was also DH in Münster, where he was elected to the dignity of DD,⁵⁶⁹ Archdeacon of Lübbecke, and Propst zu St. Johann in Minden and St. Andreas in Lübbecke.⁵⁷⁰ He was succeeded in his Minden prebend by Franz Philipp v. Esch (103).⁵⁷¹

80 Hanxleden, Hermann Caspar von

Brother of Adolf Hermann Philipp (64) and Franz Christoph (79), Hermann Caspar was also the son of Günther Egon v. Hanxleden zu Eickel and Clara Maria v. Westerholt.⁵⁷² He was sworn in at Minden on 30. June, 1734,⁵⁷³ as the successor of Hermann Dietrich v. Nehem (44)⁵⁷⁴ and emancipated on 13. September of that year.⁵⁷⁵ Like Franz Christoph, he

was also DH in Münster,⁵⁷⁶ where he was a supporter of the Fürstenberg faction.⁵⁷⁷ He died on 19. January, 1760, in his 50th year,⁵⁷⁸ and was succeeded by Otto Hermann v. Spiegel (96).⁵⁷⁹

81 Eltz, Hugo Franz Karl von

This Rhinelander, the son of Karl Anton Ernst v. Eltz zu Kempenich and Helena Catharine v. Wambold,⁵⁸⁰ was the recipient of the favor of the King of Prussia, who made him DH and DP in 1736.⁵⁸¹ He was sworn in on 26. June, 1736.⁵⁸² Hugo Franz Karl was born on 19. November, 1701, and died on 27. June, 1779.⁵⁸³ He gathered many ecclesiastical livings, including that of DH and DP in Mainz, where he succeeded to the prebend of Ferdinand Benedict v. Galen, DH in Trier, Provost zu Erfurt, Can. zu St. Alban in Mainz, and commendatory abbott of Pecsward near Pecs in Hungary.⁵⁸⁴ Eltz was seldom present in Minden, although he held the dignity of DP for 43 years. He was succeeded in his prebend in Minden by Nikolaus Franz v. Adelmann (107).⁵⁸⁵

82 Wendt, Wilhelm Adolf von

This son of Franz Wilhelm v. Wendt zu Holtfeld and Agatha Catharine v. Westphalen⁵⁸⁶ succeeded to the prebend vacated by the resignation of his brother Franz Arnold (72),⁵⁸⁷ was sworn in on 11. April, 1747,⁵⁸⁸ and emancipated on 2. September, 1748.⁵⁸⁹ There is some question about the date of his death, which the Culemann Addenda put on 7. May, 1776,⁵⁹⁰ and which Fahne assigns to 1777.⁵⁹¹ His successor, Clemens Philipp v. Spiegel (108), did not receive this prebend until 1787, but the Acta clearly state that he succeeded Wendt.⁵⁹²

83 Galen, Karl Anton von

Karl Anton was born on 18. December, 1679,⁵⁹³ the youngest son of Heinrich v. Galen zu Assen and his second wife, Anne Elisabeth v. d. Recke.⁵⁹⁴ After holding a prebend in Münster, he left the clerical estate and married on 6. June, 1713, Maria Anne v. Wolff gnt. Metternich zu Wehrden.⁵⁹⁵ (not Theodora v. Vittinghoff gnt. Schell, as recorded by Keinemann and Kohl).⁵⁹⁶ After the death of his wife, he returned to the clerical life, obtaining prebends in Münster and Osnabrück as well as in Minden.⁵⁹⁷ In Minden, he obtained collation to the first Galen Family Prebend from his nephew, the Erbkämmerer Wilhelm Ferdinand, on 16. October 1747, succeeding Clemens August (74).⁵⁹⁸ He was sworn in a month later, on 20. November.⁵⁹⁹ Karl Anton died on 11. September, 1752,⁶⁰⁰ and was succeeded in Minden by Clemens August v. Korff-Schmising (88).⁶⁰¹

84 Galen, Lothar Franz Stephan Wilhelm Michael Joseph von

This son of Christoph Bernhard Benedict v. Galen zu Ermelinghof and Anne Maria v. Falkenstein⁶⁰² was baptized on 29. September, 1723,⁶⁰³ and died on 5. June, 1767.⁶⁰⁴ He succeeded Friedrich Christian Joseph v. Galen (49)⁶⁰⁵ as the fourth incumbent of the second Galen Family Prebend in Minden, and was sworn in on 30. April, 1748.⁶⁰⁶ Lothar Franz is an uncle of Clemens August (109). He also held the Galen Family Prebend at Worms.⁶⁰⁷ He was succeeded in Minden by Ferdinand Karl v. Galen (101).⁶⁰⁸

85 Dalberg, Adolf Franz Wolfgang Eckenbert, Kämmerer von Worms gnt.

From a Rhenish family, Dalberg was the son of Hugo Philipp Eckenbert K.v.W. gnt. Dalberg and Maria Anne Josepha Sophia Zobel v. Giebelstadt.⁶⁰⁹ He was sworn in on 6. October, 1751,⁶¹⁰ as the successor to Friedrich Christian v. Ketteler (70),⁶¹¹ who had died in 1740. His emancipation took place on 2. November, 1751.⁶¹² Dalberg was also DH in Bamberg.⁶¹³ He is mentioned as Senior in 1779,⁶¹⁴ and died in 1794,⁶¹⁵ being succeeded by Karl Theodor v. Redwitz (114).⁶¹⁶

86 Bussche, Jobst Heinrich Wilhelm von dem

Born in 1725, this DH was the son of the DH Hilmer Albrecht v. d. Bussche (48) and Anne Dorothea v. Vincke.⁶¹⁷ He succeeded Heinrich v. Ledebur (65)⁶¹⁸ in his prebend in Minden, was sworn in on 13. January, 1752,⁶¹⁹ and emancipated on 24. September of that year.⁶²⁰ The Culemann Addenda erroneously give his death in August, 1760,⁶²¹ which is the date for his kinsman Georg Wilhelm Werner v. d. Bussche (89). This DH died on 1. July, 1758,⁶²² and was succeeded by Christian Heinrich Ernst v. Ledebur (94).⁶²³

87 Forstmeister v. Gelnhausen, Damian Wilhelm Caspar

The son of Johann Philipp Friedrich, Forstmeister von Gelnhausen, and Anne Margarete Elisabeth v. Schleiffras⁶²⁴ was born on 13. January, 1723,⁶²⁵ and died on 5. June, 1802.⁶²⁶ He succeeded Jobst Heinrich v. Oer (54)⁶²⁷ in his Minden prebend, was sworn in on 22. March, 1752,⁶²⁸ and emancipated on 9. May, 1755.⁶²⁹ Forstmeister also held prebends at Speyer⁶³⁰ and Paderborn, where he obtained the dignity of DD.⁶³¹ He is recorded as Senior at the time of his death,⁶³² when he was succeeded by Wilhelm Karl v. Hessenstein (116).⁶³³

88 Korff gnt. Schmising, Clemens August von

Clemens August was the son of Caspar Heinrich v. Korff-Schmising zu Tatenhausen and Antonette Helena v. Landsberg.⁶³⁴ His mother was a daughter of Franz Anton v. Landsberg zu Erwitte, who married Anne Maria v. Galen, sister of the Erbkämmerer Wilhelm Ferdinand, on 21. February, 1696.⁶³⁵ It was to this connection that Clemens August owed his collation on 3. January, 1753, by the Erbkämmerer Wilhelm Ferdinand to the prebend vacated by the death of Karl Anton v. Galen.⁶³⁶ He was sworn in on 5. February, 1753.⁶³⁷ Clemens August was born in 1721 and died on 22. April, 1787.⁶³⁸ He also held prebends in Münster, Osnabrück, and Passau.⁶³⁹ He was succeeded in Minden by Clemens August v. Galen zu Ermelinghof (109).⁶⁴⁰

89 Bussche, Georg Wilhelm Werner von dem

Another member of this well-represented Protestant dynasty, Georg was the fourth incumbent of the Bussche Family Prebend, to which he was sworn in on 26. July, 1753.⁶⁴¹ Born in 1742, he died while still very young in August, 1760.⁶⁴² He was a son of Johann Friedrich v. d. Bussche zu Hünefeld and Henriette Dorothea Johanna v. Ledebur,⁶⁴³ brother of Christian August Clamor (97), and uncle of Clamor Dietrich Ludwig Wilhelm (111) and Clamor Ernst Georg Victor (120).

90 Ledebur, Heinrich Plato von

This son of Ernst Günther v. Ledebur zu Crollage and Hedwig Sophia v. Rössig,⁶⁴⁴ was born on 8. June, 1709 and died on 4. April, 1759.⁶⁴⁵ He succeeded to the prebend of Alexander v. Hammerstein (58),⁶⁴⁶ was sworn in on 17. April, 1755,⁶⁴⁷ and emancipated a few weeks later on 30. April.⁶⁴⁸ He was DD in Minden, and also Sch. in Halberstadt.⁶⁴⁹

91 Recke, Eberhard Friedrich Christoph Ludwig von der

A son of the Thes. Wilhelm Christian v. d. Recke (75) zu Stockhausen and Sophia Dorothea Friederike v. Rochow,⁶⁵⁰ Recke was born in 1744 and died in 1816.⁶⁵¹ He received collation to the prebend freed by the death of Eberhard Hermann Jobst v. Dinklage (43)⁶⁵² from Georg Ludwig v. Bar as Turnarius on 20. March, 1755.⁶⁵³ He obtained possession on 28. May, 1755,⁶⁵⁴ but resigned a year later on 26. March, 1756,⁶⁵⁵ and was succeeded by Dietrich Victor Heinrich v. Korff (92).⁶⁵⁶ Recke married Elisabeth Dorothea Luise v. Vincke.⁶⁵⁷

92 Korff, Dietrich Victor Heinrich von

Korff succeeded the foregoing DH Recke (91),658 being sworn in on 29. April, 1756,659 and emancipated on 31. May of that year.⁶⁶⁰ He was the son of Dietrich Heinrich v. Korff zu Waghorst and Sophia Henriette v. Treskow,⁶⁶¹ and grand-nephew of Heinrich V. Itorit 2a. Waghorst and Sophia Henriette v. Treskow,⁶⁶¹ and grand-nephew of Heinrich Victor (32). He was born on 13. November, 1731,⁶⁶² and died on 12. May, 1796⁶⁶³ as Gross-Vogt zu Minden⁶⁶⁴ and Propst zu St. Marien in Minden.⁶⁶⁵ He was succeeded in his prebend by Friedrich v. Levetzow (115).666 Korff was married to Lucie Charlotte v. Buttlar.667

93 Kessel, Karl Abraham Franz Alexander von Bottlenberg gnt.

This Protestant DH was born on 31. March, 1733,668 the son of Friedrich Wilhelm Christian v. Bottlenberg gnt. Kessel zu Hackhausen and Elisabeth Josine v. Neuhoff.⁶⁶⁹ He obtained collation from Georg Ludwig v. Bar as Turnarius⁶⁷⁰ to the prebend vacated by Johann Friedrich Georg v. Vincke (66),⁶⁷¹ was sworn in on 21. October, 1756,⁶⁷² and emancipated on 17. November, a month later.⁶⁷³ He died on 7. May, 1791,⁶⁷⁴ and was succeeded by Ernst v. Vincke (112).675

94 Ledebur, Christian Heinrich Ernst von

This son of the Protestant DH Heinrich v. Ledebur (65) zu Mühlenburg and Adelheid Johanna v. d. Schulenburg 676 was born on 11. January, 1739, and died on 10. January, 1794.677 He succeeded Jobst Heinrich Wilhelm v. d. Bussche (86),678 obtaining possession on 7. September, 1758,⁶⁷⁹ with his emancipation taking place one month later on 4. October.⁶⁸⁰ In addition to this ecclesiastical dignity, Ledebur was a royal Prussian Kammerpräsident and Droste zu Altena and Iserlohn.⁶⁸¹

95 Vincke, Ernst Idel Jobst von

Ernst Idel Jobst was born on 21. February, 1738,⁶⁸² the son of Idel Jobst v. Vincke zu Ostenwalde and Beata Elisabeth v. Korff,⁶⁸³ and nephew of Johann Friedrich Georg (66). In 1762 he married Luise Sophia v. Buttlar,⁶⁸⁴ and became the father of the DHH Ernst (112) and Karl Philipp (113) and the governor of Westphalia, Ludwig v. Vincke. He became the last DD at Minden before the end of the old Empire at the insistence of Frederick II of Prussia on 6. September, 1759.685. He held the dignity of Oberstallmeister to Duke Frederick of York, and died on 21. May, 1813.686

96 Spiegel, Otto Hermann Wilhelm von

This member of the Paderborn nobility was born in 1712 on 9. October,⁶⁸⁷ the son of Johann Eckenbrecht v. Spiegel zu Ober-Klingenburg and Dorothea Elisabeth v. Gaugreben.⁶⁸⁸ He obtained possession of a prebend in Minden as successor to Hermann Caspar v. Hanxleden (80)⁶⁸⁹ on 20. March, 1760,⁶⁹⁰ and was emancipated on 26. August, 1771.⁶⁹¹ Spiegel was also DH in Paderborn⁶⁹² and Hildesheim.⁶⁹³ Although he resigned his prebend in Paderborn in 1798,⁶⁹⁴ he remained in the chapters of Minden and Hildesheim until his death in 1801.⁶⁹⁵ He was succeeded in Minden by Johann Clamor v. Bothmer (118).⁶⁹⁶

97 Bussche, Christian August Clamor von dem

This son of Johann Friedrich v. d. Bussche zu Hünefeld and Henriette Dorothea Johanna v. Ledebur⁶⁹⁷ was a brother of Georg Wihelm (89) and father of Clamor Dietrich Ludwig Wilhelm (111) and Clamor Ernst Georg Victor (120), and the fifth incumbent of the Bussche Family Prebend. He was born on 15. April, 1736, and died on 25. April, 1791.⁶⁹⁸ In Minden, Bussche was sworn in on 27. January, 1761.⁶⁹⁹ He was also DH in Osnabrück,⁷⁰⁰ but had to resign that prebend in 1766 at the time of his marriage to Christine Caroline v. Ende, his first wife, as the Protestant DHH in Osnabrück did not have the privilege of retaining their prebends while married.⁷⁰¹

98 Huber von Maur, Karl Joseph Johann Nepomuk

This son of Franz Philipp Gottfried Huber v. Maur and Christine Agnes v. Sieboldstorff⁷⁰² succeeded Karl Heinrich Anton v. Ascheberg (76)⁷⁰³ in a prebend in Minden. He was sworn in on 22. December, 1762,⁷⁰⁴ and emancipated a month later on 19. January, 1763.⁷⁰⁵ Although Hersche gives his exit from the chapter in 1769, the Acta record his presence as late as 6. August, 1781.⁷⁰⁶ Huber v. Maur died on 28. November, 1782,⁷⁰⁷, and was succeeded by Friedrich Wilhelm v. Juden (110).⁷⁰⁸

99 Kerssenbrock, Friedrich August von

Although neither the birth nor the death dates of this Protestant DH are known, Fahne lists him between brothers born in 1734 and 1739,⁷⁰⁹ and Klocke lists him as the senior member of the chapter, after the DP and DD, in 1803.⁷¹⁰ He was the son of Gottlieb Friedrich Achatz v. Kerssenbrock zu Mönchshof and Wilhelmine Charlotte v. Hahn.⁷¹¹ Kerssen-

brock obtained the dignity of Thes. in Minden, and was Droste and Landrat der Grafschaft Lippe.⁷¹² He was sworn in on 13. May⁷¹³ as the successor of Wilhelm Christian v. d. Recke (75),⁷¹⁴ and emancipated a month later on 3. June, 1765.⁷¹⁵ Kerssenbrock was married to Dorothea Elisabeth Albertine v. Hodenberg.⁷¹⁶

100 Hoerde, Leopold Ludwig August von

This son of Philipp Ludwig v. Hörde zu Schönholthausen and Sophia Luise v. d. Horst zu Milsen⁷¹⁷ was baptized on 20. October, 1752.⁷¹⁸ On 30. March, 1765, he received collation from Sch. Dalwigk as Turnarius to the prebend vacated by Friedrich Bernhard v. Wrede (77).⁷¹⁹ He was sworn in on 23. November, 1766.⁷²⁰ There is some confusion about the date of his death, with Hersche listing him as a member of the chapter until 1796,⁷²¹ and Horst saying he was dead by 1785.⁷²² The Acta, however, speak of "die durch aussterben des Dohm Capitularen Frhr. v. Hörde erledigte catholische Praebende" under the date 26. September, 1775, in connection with his successor, Cajetan v. Schaffgotsch (105).⁷²³

101 Galen, Ferdinand Karl Alexander Bernhard Anton Maria von

The son of the Erbkämmerer Wilhelm Ferdinand v. Galen (50) and his second wife, Sophia Luise v. Merveldt,⁷²⁴ Ferdinand Karl was the nephew of Wilhelm Goswin Anton (46) and Friedrich Christian Joseph (49) and half-brother of Clemens August (74). Baptized on 16. September, 1750,⁷²⁵ Galen succeeded Lothar Franz v. Galen zu Ermelinghof (84) as the fifth incumbent of the second Galen Family Prebend,⁷²⁶ was sworn in on 31. August, 1767, and emancipated on 11. May, 1771.⁷²⁷ Ferdinand Karl also held the Galen Family Prebends in Münster, Osnabrück, and Worms, and obtained a prebend in Halberstadt as well.⁷²⁸ Inasmuch as his elder brother's marriage remained without issue, in 1797 he obtained a papal dispensation, resigned his prebends, and married on 21. June Bernhardine Antonette v. Mengersen.⁷²⁹ He was succeeded in Minden by Caspar Maximilian v. Korff-Schmising (117),⁷³⁰ and died on 11. November, 1803.⁷³¹

102 Cornberg, Philipp Georg Wilhelm von

The Cornbergs were the result of the illegitimate union of the Landgraf Wilhelm IV of Hessen-Cassel with Elisabeth Wallenstein.⁷³² This DH was the son of Christian Ludwig v. Cornberg zu Lübbecke and Henriette Sophia Helena v. d. Bussche,⁷³³ was born on 13. June, 1759, and died on 19. October, 1811.⁷³⁴ He was sworn in as the successor of Georg Ludwig v. Bar (71)⁷³⁵ on 3. December, 1767,⁷³⁶ and emancipated on 14. June, 1779.⁷³⁷

During the minority of the DP Caspar Max v. Droste-Vischering (106), Cornberg administered the Dompropstei.⁷³⁸ He is listed by Klocke among the DHH in 1803.⁷³⁹

103 Esch, Franz Philipp von

Although Hersche expressed doubts about the religious affiliation of this DH,⁷⁴⁰ he clearly held a Catholic prebend in Minden, without the reservations noted in the Acta when Protestant DHH were appointed to Catholic positions (104 and 120). Franz Philipp was the son of Franz v. Esch zu Langwiessen and Maria Leopoldine v. Wintershoffen.⁷⁴¹ He succeeded Franz Christoph v. Hanxleden (79)⁷⁴² in a prebend in Minden, was sworn in on 3. December, 1771,⁷⁴³ and emancipated a few weeks later on 30. December.⁷⁴⁴ He died on 10. May, 1802,⁷⁴⁵ and was succeeded by Clamor Ernst Georg Victor v. d. Bussche (120), a Protestant.⁷⁴⁶

104 Recke, Valentin Ernst Ludwig von der

Recke was born on 15. July, 1757,⁷⁴⁷ the son of the DH Wilhelm Christian v. d. Recke zu Stockhausen (75) and Sophia Dorothea v. Rochow,⁷⁴⁸ and brother of Eberhard Friedrich Christoph Ludwig (91). Despite the protests of the chapter, King Frederick of Prussia insisted on the "praesentation eines Evangelische zu einem erledigten Catholischen Praebende und Scholasterey"⁷⁴⁹ on the death of Anton Ludwig August v. Dalwigk (73).⁷⁵⁰ The King promised the chapter "künftig wann eine evangelische Praebende zu Unserer Collation bey eurere Stift vacant werden möchte, es bey Unserer Höchsten Person dahin antragen werde, daß ein Catholicus damit providieret werde".⁷⁵¹ Recke was sworn in on 29. December, 1778,⁷⁵² and emancipated on 3. February, 1779,⁷⁵³ as DH and Sch. Later in 1779 he died,⁷⁵⁴ and was succeeded in November by Caspar Max v. Droste-Vischering (106).⁷⁵⁵

105 Schaffgotsch, Cajetan Karl Wenceslaus von

There appears to be some difficulty about the Christian names of this DH. He is clearly given the names Karl Wenceslaus on the AT,⁷⁵⁶ and is called "Carl v. Schaffgotsch, DH zu Breslau" in the initial royal nomination of 26. September, 1775,⁷⁵⁷ but in the act of collation he is called Cajetan,⁷⁵⁸ and later Cajetan Gotthard.⁷⁵⁹ In the documents attesting his baptism on 15. February, 1754,⁷⁶⁰ he is called Carl Gotthard.⁷⁶¹ Klocke calls him Cajetan in his list of DHH in 1803.⁷⁶² In conformity with the common practice of the age, he probably had many given names. He was the son of Karl Gotthard v. Schaffgotsch and Maria Anne v. Hatzfeld-Gleichen,⁷⁶³ and succeeded Leopold Ludwig August v. Hörde (100)⁷⁶⁴ in

a prebend in Minden by royal collation.⁷⁶⁵ Schaffgotsch was sworn in on 9. February, 1779,⁷⁶⁶ after considerable difficulty over his genealogy, and was emancipated on 17. May of that year.⁷⁶⁷

106 Droste zu Vischering, Caspar Maximilian Joseph Anton Maria von

Upon the death of DP v. Eltz in 1779, the King nominated the barely nine year old Droste-Vischering to succeed him as DP, although he was not a member of the chapter. Eltz's prebend had fallen to DH Dalberg as Turnarius, and the King evidently attempted to force Dalberg to grant collation to Droste-Vischering. When this was not successful, the King ordered a prolongation of the admission of Dalberg's candidate until the issue was resolved.⁷⁶⁸ On 26. November, 1779, DH Forstmeister as Turnarius granted collation to Droste Vischering for the prebend vacated by Valentin Ernst Ludwig v. d. Recke (104),⁷⁶⁹ with the swearing in taking place on 17. February, 1780.⁷⁷⁰ It was finally agreed between King and chapter that Philipp Georg Wilhelm v. Cornberg (102) would administer the Dompropstei until Droste-Vischering reached the age of 20.⁷⁷¹ Caspar Max was born on 12. July, 1770,⁷⁷² the son of Clemens August v. Droste-Vischering and Sophia Alexandrine v. Droste zu Füchten.⁷⁷³ He also held a prebend in Münster,⁷⁷⁴ where he was appointed as Weihbischof to the Elector Max Franz in 1794.⁷⁷⁵ He remained a member of the Münster chapter throughout the Napoleonic period, was elected as DD of the reorganized chapter in 1823, and became Bishop of Münster by the election of 15. June, 1825.⁷⁷⁶ Klocke lists Caspar Max as DP in Minden in 1803.⁷⁷⁷ He died on 3. August, 1846.⁷⁷⁸

107 Adelmann von Adelmannsfelden, Nikolaus Franz Xavier

This member of the Swabian Reichsritterschaft⁷⁷⁹ was the choice of Adolf Franz v. Dalberg (85) to succeed to the prebend vacated by the death of DP Eltz (81),⁷⁸⁰ and, after considerable difficulty with the Prussian King, was sworn in on 2. January, 1781,⁷⁸¹ and emancipated on 6. August of that year.⁷⁸² Nikolaus was the son of Joseph Anselm Patricius Adelmann v. Adelmannsfelden and Johanna Josepha Antonette v. Reischach,⁷⁸³ and was also DH in Augsburg and Can. in Ellwangen.⁷⁸⁴ He was born on 5. December, 1756,⁷⁸⁵ and is listed as a member of the chapter in 1803.⁷⁸⁶

108 Spiegel, Clemens Philipp von

This son of Dietrich Hermann v. Spiegel zu Desenberg und Canstein and Adolphine v. Landsberg⁷⁸⁷ was born on 20. October, 1760, and died on 24. June, 1833.⁷⁸⁸ He succeeded to the prebend formerly held by Wilhelm Adolf v. Wendt (82),⁷⁸⁹ was sworn in on 8.

March, 1787,⁷⁹⁰ and emancipated in the following month on 11. April.⁷⁹¹ Spiegel obtained the dignity of Sch. in Minden,⁷⁹² was also DH in Paderborn, and a priest.⁷⁹³ He is among those listed as DHH in Minden in 1803.794

109 Galen, Clemens August Maria Joseph Johann Nepomuk von

This seventh incumbent of the first Galen Family Prebend in Minden was a son of Johann Philipp Franz Joseph v. Galen zu Ermelinghof and Maria Theresa v. Rollingen,⁷⁹⁵ and a nephew of Lothar Franz (84). He obtained collation from the Erbkämmerer Clemens August v. Galen on 14. July, 1787, as successor of Clemens August v. Korff-Schmising (88), and was sworn in on 27. September of that year.⁷⁹⁶ Although suspended from the privileges of his prebend because of flight to avoid his debtors,⁷⁹⁷ he is listed as a member of the chapter in 1803,⁷⁹⁸ retaining his prebend until his death on 13. May, 1809.⁷⁹⁹

110 Juden, Friedrich Wilhelm von

Listed as a member of the chapter in 1803,⁸⁰⁰ this son of Georg Friedrich Erasmus v. Juden zu Borgholz and Maria Sophia v. Rubel⁸⁰¹ succeeded to the prebend formerly held by Karl Joseph Huber v. Maur (98).⁸⁰² His swearing in took place on 12. February,⁸⁰³ and his emancipation on 24. March, 1789.804

111 Bussche, Clamor Dietrich Ludwig Wilhelm von dem

Although the AT and Klocke indicate that this DH was not a member until 1802,⁸⁰⁵ the Acta clearly indicate that it was his brother, Clamor Ernst Georg Victor (120), who was admitted at that time.⁸⁰⁶ Clamor Dietrich Ludwig Wilhelm must, therefore, be the brother who obtained possession of the Bussche Family Prebend upon the death of his father in 1791, and was sworn in on 21. July.⁸⁰⁷ He was the son of the DH Christian August Clamor v. d. Bussche (97) and Christine Caroline v. Ende,⁸⁰⁸ was born on 14. September, 1778, and died on 6. September, 1815, of wounds received at the battle of Waterloo as a Hanoverian Lieutenant Colonel.⁸⁰⁹ He was a nephew of Georg Wilhelm (89) and a brother of Clamor Ernst Georg Victor (120).

112 Vincke, Ernst Idel Jobst Victor Friedrich August Wilhelm von

Born in 1768⁸¹⁰ as eldest son of the DD Ernst Idel Jobst v. Vincke (95) zu Ostenwalde and Luise Sophia v. Buttlar,⁸¹¹ Ernst succeeded Karl Abraham v. Kessel (93)⁸¹² in a prebend in Minden, where he was sworn in on 29. December, 1791,⁸¹³ and emancipated on 30. January of the following year.⁸¹⁴ He was a brother of the DH Karl Philipp (113). Ernst succeeded his father as Herr zu Ostenwalde, and served as a Brigadier in the battle of Waterloo.⁸¹⁵ He

remained in the Minden chapter in 1803.⁸¹⁶ Ernst v. Vincke married Eberhardine v. Dalwigk, and rose to the rank of Lieutenant General in the service of Hanover before his death on 16. Augustt, 1845.⁸¹⁷

113 Vincke, Karl Philipp Victor August Friedrich von

Born in 1770 or 1771,⁸¹⁸ Karl Philipp was the second son of the DD Ernst Idel Jobst v. Vincke (95) and Luise Sophia v. Buttlar.⁸¹⁹ He was sworn in at Minden on 5. January⁸²⁰ and emancipated on 2. February, 1795⁸²¹ and is listed by Klocke as DH in 1803.⁸²² He died in 1813 as a major in the Prussian army.⁸²³

114 Redwitz, Karl Theodor Ernst von

This son of Johann Victor Karl Wilhelm v. Redwitz zu Schmölz and Maria Eva Catharine v. Hettersdorf⁸²⁴ was sworn in at Minden on 24. June, 1799,⁸²⁵ as the successor of Adolf Franz v. Dalberg (85).⁸²⁶ His emancipation took place on 3. September of that year.⁸²⁷ Redwitz was also DH in Paderborn, Eichstätt, and Würzburg.⁸²⁸ He ist listed by Klocke among the DHH in 1803.⁸²⁹

115 Levetzow, Friedrich Karl Ludwig von

A son of Friedrich v. Levetzow zu Hohenwulsch and Sophia Helena v. Feetz,⁸³⁰ Levetzow was born on 13. October, 1782.⁸³¹ He received the royal collation on 8. August, 1796, to succeed to the prebend of Dietrich Victor Heinrich v. Korff (92).⁸³² Sworn in on 10. June, 1801,⁸³³ he is among those listed by Klocke as DHH in 1803.⁸³⁴

116 Hessenstein, Wilhelm Karl von

This nobleman received the royal collation to succeed Damian Wilhelm Caspar Forstmeister v. Gelnhausen (87) on 12. July, 1802.⁸³⁵ Although the Acta record his resignation on 13. March, 1804,⁸³⁶ Klocke says he is listed as admitted in 1806, although contrary to the statutes of the chapter.⁸³⁷ I am inclined to regard Hessenstein as another military officer enjoying the revenues of a vacant prebend.

117 Korff gnt. Schmising, Caspar Maximilian von

Caspar Max, son of Clemens August v. Korff-Schmising zu Tatenhausen and Elisabeth Bernhardine v. Nagel,⁸³⁸ received collation from the Erbkämmerer Clemens August v. Galen on 16. August, 1797, to succeed Ferdinand Karl v. Galen (101) in the second Galen Family Prebend.⁸³⁹ A legal conflict between the Erbkämmerer and the chapter prevented

his swearing in until 6. June, 1803.840 Schmising was born in 1790,841 but the date of his death is unknown. He was also DH in Halberstadt.⁸⁴²

118 Bothmer, Johann Clamor Hilmer von

Born 30. December, 1781,⁸⁴³ Bothmer was the son of Johann Adolf Ludwig v. Bothmer zu Schwegerhof in the Bishopric of Osnabrück and Juliana Luise Amalia v. Wendt.⁸⁴⁴ Upon the death of Otto Hermann v. Spiegel (96)⁸⁴⁵ Bothmer received a prebend in Minden, where he was sworn in on 29. December, 1803,⁸⁴⁶ and emancipated on 4. April, 1804.⁸⁴⁷ He was a brother of Adolf Karl v. Bothmer (119).

119 Bothmer, Adolf Karl Ludwig Franz von

Although listed as sworn in on 28. May, 1803,⁸⁴⁸ on the AT, and included in Klocke's list,⁸⁴⁹ the Acta do not record the admission of this DH. He ist mentioned as having been born on 9. August, 1771,⁸⁵⁰ and there ist other discussion of him, but no date for his admission or emancipation. I suspect that he was nominated for the Forstmeister prebend held by Hessenstein (116), but did not obtain possession during the period recorded in the Acta, Bothmer was DH in Osnabrück.851

120 Bussche, Clamor Ernst Georg Victor von dem

This son of Christian August Clamor v. d. Bussche (97) zu Hünefeld and Christine Caroline v. Ende⁸⁵² was born on 17. April, 1774, and died on 13. December, 1827.⁸⁵³ Although confused with his brother Clamor Dietrich Ludwig Wilhelm (111) in the AT and RW,⁸⁵⁴ the Acta clearly record his collation by the King, with all four of his given names, on 31. May, 1802, to the Catholic prebend vacated by the DH Esch (103).⁸⁵⁵ He was sworn in, again with all given names, on 5. April, 1804, 856 and emancipated in the following month on 5. May.⁸⁵⁷
