MySQL Enterprise Backup 8.2.0 is the latest release for MySQL Enterprise Backup. It only supports MySQL Server 8.2.0. For MySQL 8.0, use the MySQL Enterprise Backup version with the same version number as the server. For MySQL Server 5.7, please use MySQL Enterprise Backup 4.1.

- **Important Change:** For platforms on which OpenSSL libraries are bundled, the linked OpenSSL library for MySQL Enterprise Backup has been updated to version 3.0.10. Issues fixed in OpenSSL version 3.0.10 are described at <https://www.openssl.org/news/cl30.txt>. (Bug #35732474)
