

Starbucks for Life: 2024 Holiday Edition Member Game Official Rules - US

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility:

Starbucks for Life: 2024 Holiday Edition (the "Promotion") includes a collect and win game ("Collect and Win Game"), an instant win game ("Instant Win Game"), and two (2) separate sweepstakes ("Sweepstakes") prize pools (each a "Prize Pool") that randomly award prizes ("Prizes") (see Section 4 for details and Section 7 for available Prizes). Employees of Starbucks Corporation (the "Sponsor") will comprise its own Prize Pool for the Sweepstakes, which shall be referred to as the "Partner Sweepstakes Prize Pool." Non-employees of the Sponsor will comprise the "Consumer Sweepstakes Prize Pool." Starbucks Partners (employees) are eligible to win Instant Win Game Prizes, the Partner Sweepstakes Prize Pool Prizes and certain Collect and Win Game Prizes (see Section 5 below) but are not eligible to win the Consumer Sweepstakes Prize Pool Prizes.

The Promotion is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old and who are members of the Starbucks® Rewards loyalty program at the time of entry ("Entrant(s)").

Employees of Merkle Inc. and any of their direct or indirect parent and affiliate companies, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. Employees of Marriott International, Inc. are not eligible to win the Collect and Win Game Second Prize. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a Prize is contingent upon fulfilling all requirements set forth herein.

2. Sponsor:

3. Timing:

The Promotion begins on December 2, 2024 at 4:00 a.m. Pacific Time ("PT") and ends on January 5, 2025 at 11:59 p.m. PT (the "Promotion Period").

- A "Day" begins at 12:00 a.m. PT and ends at 11:59 p.m. PT, except the first Day which begins at 4:00 a.m. PT and ends at 11:59 p.m. PT.
- A "Week" begins each Monday and ends the following Sunday.

Administrator's computer is the official time-keeping device for this Promotion.

4. How to Enter for a Chance to Win Prizes:

Register for this Promotion: During the Promotion Period, visit starbucksforlife.com ("Promotion Site") and sign into your Starbucks Rewards account ("Account").

Earn/Receive Instant Win Game Plays: Entrants can earn/receive game plays (each a "Game Play") throughout the Promotion Period by the methods set forth below. Once earned Game Plays are deposited into Entrant's Account, Entrants can redeem them to play the game at any time during the Promotion Period.

(A) Each Entrant will receive one (1) Game Play deposited into their Account for registering for the Promotion (first visit only) and for logging in on each Friday during the Promotion Period (December 6, 2024, December 13, 2024, December 20, 2024, December 27, 2024, and January

3, 2025). If you register on a Friday during the Promotion Period, you will receive two (2) Game Plays.

(B) Entrants can earn Daily Game Plays (each Day) by taking the actions outlined below. There are two (2) ways to earn Daily Game Plays.

(1) Make a Starbucks Purchase Using a payment method linked to your Account (either a registered Starbucks Card or other payment linked method) or by scanning your Starbucks® App prior to checkout: During the Promotion Period, make an instore Starbucks purchase (excluding alcoholic beverages, Starbucks Card and Starbucks Card reloads) using a Starbucks Card or other payment method linked to your Account in the App or by scanning your Starbucks App to pay at an participating Starbucks store in the United States (herein a “Qualifying Purchase”). You will receive one (1) Game Play deposited into your Account, except for each Monday during the Promotion Period (December 2, 2024, December 9, 2024, December 16, 2024, December 23, 2024, and December 30, 2024) where you will receive two (2) Game Plays deposited into your Account.

(2) Enter without Making a Purchase (“Alternate Method Request”): During the Promotion Period, to receive a Game Play without making a purchase, visit the Promotion Site and follow the links and instructions to complete and submit the entry form which includes providing your first and last name and valid email address associated with your Account and submitting answers to the questions. An email with a unique link will be sent to your Account email address. Click on the unique link to enter the Promotion Site and sign into your Account and you will receive one (1) Game Play deposited into your Account, except for each Monday during the Promotion Period (December 2, 2024, December 9, 2024, December 16, 2024, December 23, 2024, and December 30, 2024) where you will receive two (2) Game Plays deposited into your Account.

Limit: Except as expressly provided below or receiving a bonus Game Play, each Entrant may earn up to two (2) Game Plays per Day during the Promotion Period by either making up to two (2) Qualifying Purchases; or up to two (2) Alternate Method Requests; or any combination of these two methods for a total of two (2) Game Plays per Day. Each Entrant may earn up to four (4) Game Plays each Monday during the Promotion Period by either making up to two (2) Qualifying Purchases; or up to two (2) Alternate Method Requests; or any combination of these two methods for a total of four (4) Game Plays each Monday during the Promotion Period.

Earn Bonus Game Plays: Each Entrant may receive bonus Game Plays either by completing the “Activity” listed below or by making an Alternate Method Request (as described above in Section 4(B)(2)) and selecting the particular Activity for which you would like to apply the Alternate Method Request. Game Play Limits: Limits for earning/receiving Game Plays are listed above.

How to Play the Game: Each Game Play earned/received will be deposited into your Account. At any time, during the Promotion Period, you may sign into your Account and follow the links and instructions to redeem Game Plays to play the game. You will receive either an Instant Win Game Prize (see Section 7), one (1) Collect and Win Game game piece ("Game Piece") (see Section 5), one (1) Game Play, or one (1) Sweepstakes entry into the applicable Prize Pool drawing. If you are a potential winner of a Prize, you will be provided directions for validation. All potential winners are subject to verification before any Prize will be awarded. Administrator is responsible for the functionality of the game.

Multiple Entrants are not permitted to share the same email address or Account. Each Entrant is limited to only one (1) Account. In the event of a dispute as to the identity of any Entrant, Sponsor and Administrator will rely on the information submitted by the Entrant to register for this Promotion and used to enroll in the Starbucks® Rewards loyalty program. If any additional information provided by Entrant is inconsistent with the information provided at registration for this Promotion or enrollment into

Starbucks® Rewards loyalty program, Sponsor and/or Administrator may disqualify such Entrant, and such disqualification may result in the forfeiture of any prizes won. Sponsor, in its discretion, may require additional documentation from Entrant to show proof of Entrant's identity.

5. Collect and Win Game/Instant Win Game/Sweepstakes Functionality:

Administrator is an independent judging organization whose decisions as to the administration and operation of the Game and the selection of potential winners for each are final and binding in all matters related to the Promotion.

For the Collect and Win Game: There are six (6) Collect and Win Game prize types (Grand Prize: Starbucks for Life; First Prize: \$1,000 Delta Gift Card; Second Prize: \$500 Marriott Bonvoy Gift Card; Third Prize: Reserve Umbrella; Fourth Prize: 100 Stars; and Fifth Prize: 1,000 Stars; see details below in Section 7) (each a "Prize Type"). Each Prize Type has three (3) unique Game Pieces. Two (2) of the three (3) Game Pieces for each Prize Type will be awarded regularly to Entrants. However, there will be a limited number of the third Game Pieces for each Prize Type ("Rare Game Piece") correlating to the number of prizes offered for each Prize Type as set forth in the table below.

Each Rare Game Piece will be associated with a random, computer-generated winning time during the Promotion Period. See the Promotion Site for the Rare Game Piece for each Prize Type. If you are the first player to play the game at or after the randomly generated winning time you will be awarded a Rare Game Piece. Once you have collected all three (3) Game Pieces for the applicable Prize Type, you will be a potential winner of the applicable Prize Type.

For the Sweepstakes: Administrator will randomly select the potential Sweepstakes winners from all eligible entries awarded for each respective Prize Pool during the Promotion Period on or around January 6, 2025.

For the Instant Win Game: There will be 9,950,500 computer-generated and randomly seeded winning times. There are select Instant Win Game Prizes only available during certain Weeks of the Promotion Period (see Section 7 below). If you are the first player to play the game at or after one of the randomly seeded times, you will be a potential instant winner of the Prize indicated.

6. Verification of Winners:

All potential winners are subject to verification by Sponsor or Administrator. An Entrant is not a winner of any prize, even if the Instant Win Game, Collect and Win Game or Sweepstakes should so indicate, unless and until Entrant's eligibility and the potential winning Game play/entry has been verified and Entrant has been notified that verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Any play that occurs after the system has failed for any reason is deemed a defective play, is void, and will not be honored.

Receiving a prize is contingent upon compliance with these Official Rules. 10. General Conditions:

Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Promotion, or any event or cause beyond Sponsor's control (e.g. events such as natural calamities, national emergencies, wide spread illnesses, declarations of war, acts of God, acts of terrorism) interferes with any aspect of the Promotion, including but not limited to fulfillment of the prize(s), as determined by Sponsor in its sole discretion. In such event, Sponsor reserves the right to modify the prizes offered herein and to award the prizes at random from among the eligible entries or plays received up to the time of the impairment. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion, including but not limited to submitting fraudulent game plays, or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. In no event will more prizes than are stated in these Official Rules be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received. In the event there is a discrepancy or inconsistency between, any other statements contained in any Sweepstakes-related materials (including printed versions of these Official Rules) and the Official Rules as posted on the Promotion Site, the Official Rules as posted on the Promotion Site shall prevail, govern, and control.

11. Limitations of Liability:
