Officials study implications of Supreme Court ruling on military tribunals in GTMO

The Supreme Courts decision on June 29 specifically invites the administration to work with Congress to change the law so it can try some detainees through military tribunals, said senior officials from the Departments of Justice and Defense.

The Supreme Court ruled 5-3 last week that military commissions for detainees charged with war crimes would violate the Uniform Code of Military Justice as well as four Geneva Conventions.

While ruling against military tribunals for detainees at Guantanamo Bay, Cuba, as they currently stand, the court's decision notes that "nothing prevents the administration from going to Congress to seek the authorities it feels are necessary," an official told reporters via teleconference.

In fact, Justice Stephen Breyer offered "an implicit invitation" encouraging the administration to do so, he noted.

President Bush said he would explore this option in hopes of determining a way forward. Defense and Justice officials called the Supreme Court ruling "a very significant decision" and said they are studying it to assess its full implications.

"The Supreme Court has spoken," an official said. "We are carefully reviewing that decision."

In the meantime, "all options are on the table" regarding the next course of action, an official said.

The June 29 decision directly affects only 14 detainees at Guantanamo Bay. Ten of them were already facing commissions on charges of violating the laws of war.

Charges had been prepared for another four detainees, but they had not yet been arraigned, a defense official said.

However, officials said today the decision could ultimately affect 40 to 80 detainees who are expected to be charged in the future.

Nothing in the decision takes issue with the detention of some 450 prisoners at Guantanamo Bay, officials emphasized. "The court recognizes that this is a unique conflict against a unique enemy and in fact a dangerous one," an official said.

"The court was not questioning" the right to detain these enemy combatants during hostilities, he said. White House Press Secretary Tony Snow issued a similar sentiment during today's White House briefing. "Nobody gets a 'get out of jail free card," he said of the decision.

Snow acknowledged that the war on terror poses new considerations. "This is a different kind of war and I think it creates a different kind of legal atmosphere," he said.

Today's decision was based on the case Hamdan v. Rumsfeld, filed on behalf of Salim Ahmed Hamdan.

A former driver and bodyguard for al Qaeda leader Osama bin Laden, Hamdan was picked up in Afghanistan in late 2001 and turned over to U.S. officials. He has been detained at Guantanamo Bay since 2002.

Hamdan challenged the legality of the U.S. government trying him for alleged war crimes before a military commission under a presidential order.

Hamdan argued that he was entitled to a court-martial convened under the U.S. Code of Military Justice or a civilian trial before a federal judge.

The teams also battled heat, time and occasional technical malfunctions.

for the first couple of clues," said SW3 Jason Bowles, member of the Seabee team, "so, we had to back-track and rephotograph those clues."

"I think this is great entertainment," said Bowles. "It's a good thing for young sailors to do that's fun and interesting, and helps them stay out of trouble."

In the end, it was 'Forces of Nature' made up of Spc. Robert Parker, Lisa Parker, YN3 Sam Ouch, and YN3 Angel Datil, who won the hunt. Each team member received a Sony Micro Hi-Fi component system.

Second place went to 'The Ringers' with each team member receiving a fishing pole with tackle box, and a certificate for a free one-hour boat rental.

CNO calls diversity a strategic imperative

Chief of Naval Operations (CNO) Adm. Mike Mullen addressed a packed audience at the Naval Air Systems Command Total Force Diversity Day on June 29.

Mullen left no doubt about the importance of pursuing diversity at every level in the Navy, calling it a "strategic imperative" and reminding the attendees that the Navy is engaged around the globe.

"Having the cultural skills, having the diverse back-grounds in order to literally achieve our mission is really critical", said Mullen. "That is why [diversity] is a strategic imperative."

This level of engagement, he argued, requires a much better understanding of cultural norms and values than Sailors typically have right now.

While the CNO noted that the Navy has made great strides in improving diversity in recent years, the pace of globalization and the war on terrorism have made it necessary to renew those efforts and adopt change even faster.

"We've got to create a sense of urgency and a belief and a commitment," he said. "Leadership has to say it: 'We've got to change.""

Mullen noted that the Navy has created a new Diversity Concept of Operations, which lays the groundwork for how the service will seek to improve both awareness and opportunities at all leadership levels.

Diversity, the CNO stressed, is about creating opportunities for all, not breaking down barriers for some.

And he pressed the audience hard to begin a healthy dialogue about the subject.

"Part of how we got here



CNO Adm. Mike Mullen is because we're afraid to talk about the subject. We don't know how to talk about it. We've got to get over that.

Amongst friends, it's a challenging issue. We worry about ticking people off, about saying the wrong thing," he said.

Understanding one another's concerns was a vital first step to making progress, Mullen argued.

"I can't see diversity from a minority position," he noted. "I have not grown up in those shoes. I didn't live that way, and I need help understanding it. And I need understanding that that is the case, not an expectation that I would pick it up instantly."

Mullen also encouraged

leaders in the Navy to take on what he termed "accountable mentorship."

He argued that leaders must consider it a primary responsibility to ensure the success of those they mentor, aggressively tracking career milestones.

"As a mentor, it's my responsibility to make sure that individual makes it," he said. "We have got to get [diversity] right or it jeopardizes us as an institution. The Navy is my command," Mullen added, "and this is a big part of making sure we get it right."

Stolen VA laptop turned in to FBI

The stolen Department of Veterans Affairs laptop computer and hard drive containing the personal information of more than 26 million veterans were turned in to the FBI yesterday, the Veterans Affairs secretary said before Congress June 29.

Reports indicate that the FBI has made a preliminary determination that data contained on the computer and hard drive has not been accessed.

There have been no reports of identity theft or other criminal activity related to the stolen



computer, R. James Nicholson told the House Veterans Affairs Committee. He added that the VA would still honor its promise of free credit monitoring for a year.

An unnamed individual turned over the laptop and hard drive to FBI officials in Balti-

more. No persons are in custody at this time, officials said.

The laptop and hard drive were stolen from the Montgomery County, Md., home of a VA employee on May 3. Government officials do not believe the data on the laptop was the target of the burglary, and consider the break-in a random theft.

"This has brought to the light of day some real deficiencies in the manner we handled personal data," Nicholson said. "If there's a redeeming part of this, I think we can turn this around."
