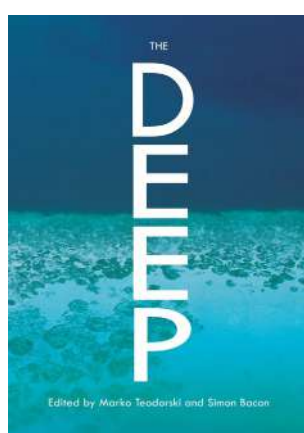

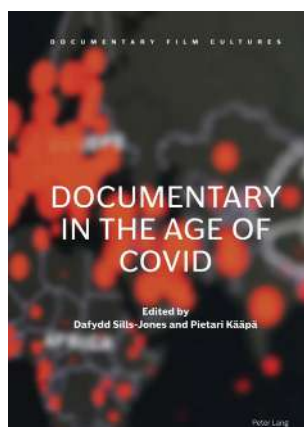

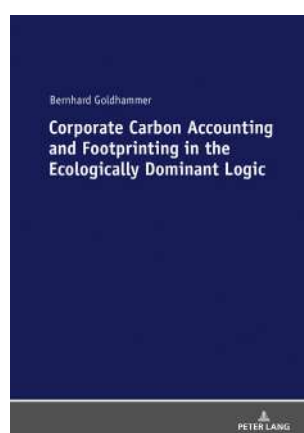

In order to reach sustainable supply chains, the Ecologically Dominant Logic calls for improvement in measurements. With regard to climate change, this is the task of corporate carbon accounting and footprinting. This book contributes to these topics by proposing a double-entry based bookkeeping approach for carbon accounting, that enables continuous reporting along the supply chain, supports both product and corporate carbon footprinting and is compliant with the established carbon accounting standards. 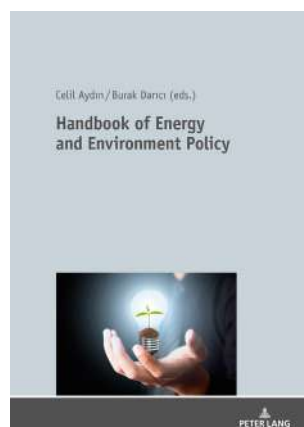

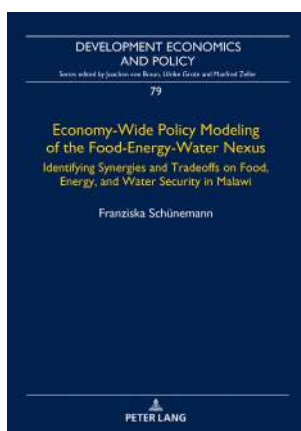

Food, energy, and water are intrinsically connected through economic and ecological linkages and dependent on limited resources that are particularly threatened in developing countries by climate change, economic and population growth. A nexus perspective that simultaneously encompasses food, energy, and water has thus become crucial to avoid inefficient resource use. This volume contributes to the research on the food-energy-water nexus by first developing three integrated modeling frameworks for ex-ante policy simulation and then analyzing four policies in Malawi – biofuels production, irrigation expansion, improved cookstoves and agroforestry. The analyses show that the design of policies matters and that the inclusion of smallholders generally maximizes synergies between food, energy and water security. Integrated modeling frameworks are vital for analyses of policies that simultaneously affect the economic, social, and environmental spheres to quantify relevant tradeoffs.

As Dominant Western Worldviews (DWWs) proliferate through ongoing structures of globalization, neoliberalism, extractive capitalism, and colonialism, they inevitably marginalize those deemed as 'Other' (Indigenous, Black, Minority Ethnic, non-Western communities and non-human 'Others', including animals, plants, technologies, and energies). Los indicadores jurídicos también servirán como herramientas innovadoras de toma de decisiones, en particular para llevar a cabo reformas legislativas informadas y no ciegas, así como para evitar regresiones en el derecho ambiental.

El método matemático utilizado permite, a través de un cuestionario que aborda todas las etapas jurídicas e institucionales de la aplicación de los textos legales, proporcionar datos que destaquen tanto las áreas de mejora como las fortalezas en la aplicación de la ley.

Este ensayo es una actualización de un primer libro publicado en 2018 por el Institut de la Francophonie pour le développement durable. Es el resultado de una asociación entre el Centro Internacional de Derecho Ambiental Comparado y la Cátedra Normandía para la Paz.

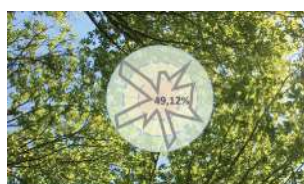

This book presents a new method for measuring the effectivity of national and international environmental law. It took four years of research and experimentation to develop a way to construct evidence-based legal indicators. The existing environmental indicators evaluate only statistical, scientific or economic data.

With legal indicators, governments, parliaments and other public and private actors, including environmental NGOs, will be able to assess accurately and concretely, on a scientific basis, what the gaps, progress and setbacks in the implementation of international conventions and national laws are. The legal indicators will also serve as innovative tools for decision-making, in particular to carry out legislative reforms in full knowledge of the facts and not blindly, as well as to avoid regressions in environmental law.

The mathematical method used makes it possible, through a questionnaire addressing all the legal and institutional stages of the application of legal texts, to provide data highlighting both the points to be improved and the strengths of the application of the law.

This essay is an update of a first book published in 2018 by the Institut de la Francophonie pour le développement durable. It is the result of a partnership between the International Centre for Comparative Environmental Law and the Normandy Chair for Peace.

**What is Cli-Fi?**

Climate change fiction is a new literary phenomenon that emerged at the turn of the twenty-first century in response to what may be society's greatest challenge. Climate change is already part responsible for extreme weather events, flooding, desertification and sea level rise, leading to famine, the spread of disease, and population displacement. Cli-fi novels and films are typically set in the future, telling of disaster and its effect on humans, or they depict the present, beset by dilemmas, conflicts or conspiracies, and pointing to grave consequences. At their heart are ethical and political questions: will humankind rise to the challenge of acting collectively, in the interest of the future? What sacrifices will be necessary, and is a green dictatorship our only hope for survival as a species?

Each chapter in this volume offers a way of reading a particular literary text or film, drawing attention to themes, formal features, reception, contribution to public debate, and issues for class discussion. Popular novels and films (Kim Stanley Robinson's *Science in the Capitol* trilogy, Michael Crichton's *State of Fear*, Ian McEwan's *Solar*, and *The Day after Tomorrow*) are examined alongside lesser known writing (for instance J. G. Ballard's «proto-climate change» novel *The Drowned World* and Antti Tuomainen's Finnish thriller, *The Healer*), and films not generally thought of as being about climate change (*Frozen* and *Take Shelter*).

The book, which includes an introduction tracing the emergence and influence of cli-fi, is directed towards general readers and film enthusiasts as well as teachers and students. Written in an accessible style, it fills the gap between academic studies and online blogs, offering a comprehensive look at this timely new genre.

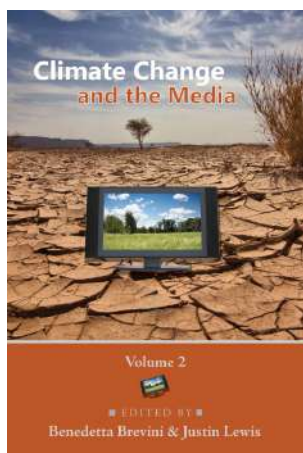

It is now more than a quarter of a century since the Intergovernmental Panel on Climate Change published their first comprehensive report on the dangers posed by anthropogenic global warming. Over the last twenty-five years the weight of evidence about the causes and consequences of climate change has become compelling. The solutions are fairly simple—we must switch to more sustainable and efficient forms of energy production. In homage to Berta, who was brutally assassinated for her activism in 2016, this book takes the reader on an affective journey departing from the violent affects experienced by the Lencas due to colonial disruption, contemporary industrialization, and criminalization, towards COPINH's political and social intervention fueled by outrage, resistance, transnational solidarity, care, mourning, and hope. In this way, subaltern actors nurture the power to—in line with Brian Massumi's interpretation of affect—transform necropolitics into natality with the aim of creating a fairer and better world.

The necessity of all states to act together on these problems, which threaten the present and future of humanity, and find the solution has revealed the "global" character of the process. The interdependence created by economic development and environmental problems brought a new meaning and dimension to both national and international politics. Especially the recent pandemic has made the global nature of environmental issues more understandable. In this context, it seems necessary to create a work that deals with current debates in the field, which will help identify the problems in the field and find solutions to them.

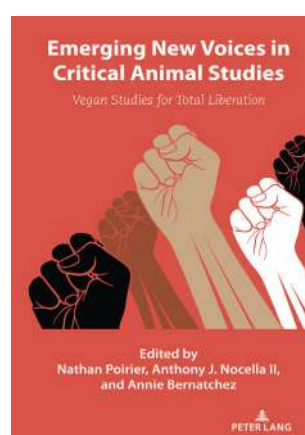

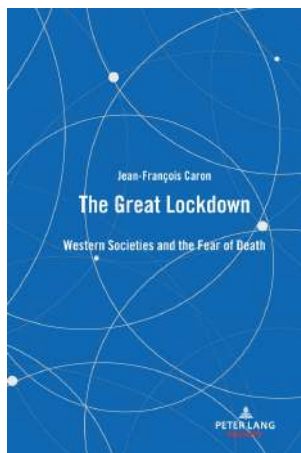

It is being said that we should all be proud of the way we are confronting the Covid-19 pandemic. Rather than privileging profits and trade, Western societies have made the noble decision to save lives at all costs. Indeed, the logic that has prevailed is that accepting any trade-off between saving lives and saving the economy is an unacceptable and monstrous idea, which is why liberal democracies worldwide have chosen to shutter businesses and force people to self-quarantine in their homes as much and for as long as possible. A vast majority of citizens and political leaders deemed that acting otherwise would have been nothing else but pure moral bankruptcy.

Is it, however, possible that Western societies have gone the wrong way by embracing this inherently basic and impoverished version of life? The reason why a significant majority of us are unable to see this truth is because of our refusal to accept death and the tragic essence of human life which is the result of the various cultural parameters we have grown accustomed to over the past decades that followed WWII. The Covid-19 pandemic has simply been the triggering factor that has allowed these factors to reinforce the full strength they wield on our understanding of life. Defined primarily by a fear of death, the desire to prolong life as much as possible and minimize the hurdles individuals have to face during their existence has created a beast that is, in appearance, reassuring to the fearful creatures we have become.

This beast has aseptified societies that refute the tragic nature of life and are willing to hinder individuals' freedom and what makes our existence inherently humane. However, without realizing it, this Leviathan that now takes the form of a "nanny state" has altered our nature from individuals able and encouraged to enjoy life to people whose only destiny is to simply survive for as long as possible, without any other purpose than to avoid anything that might jeopardize this objective.
