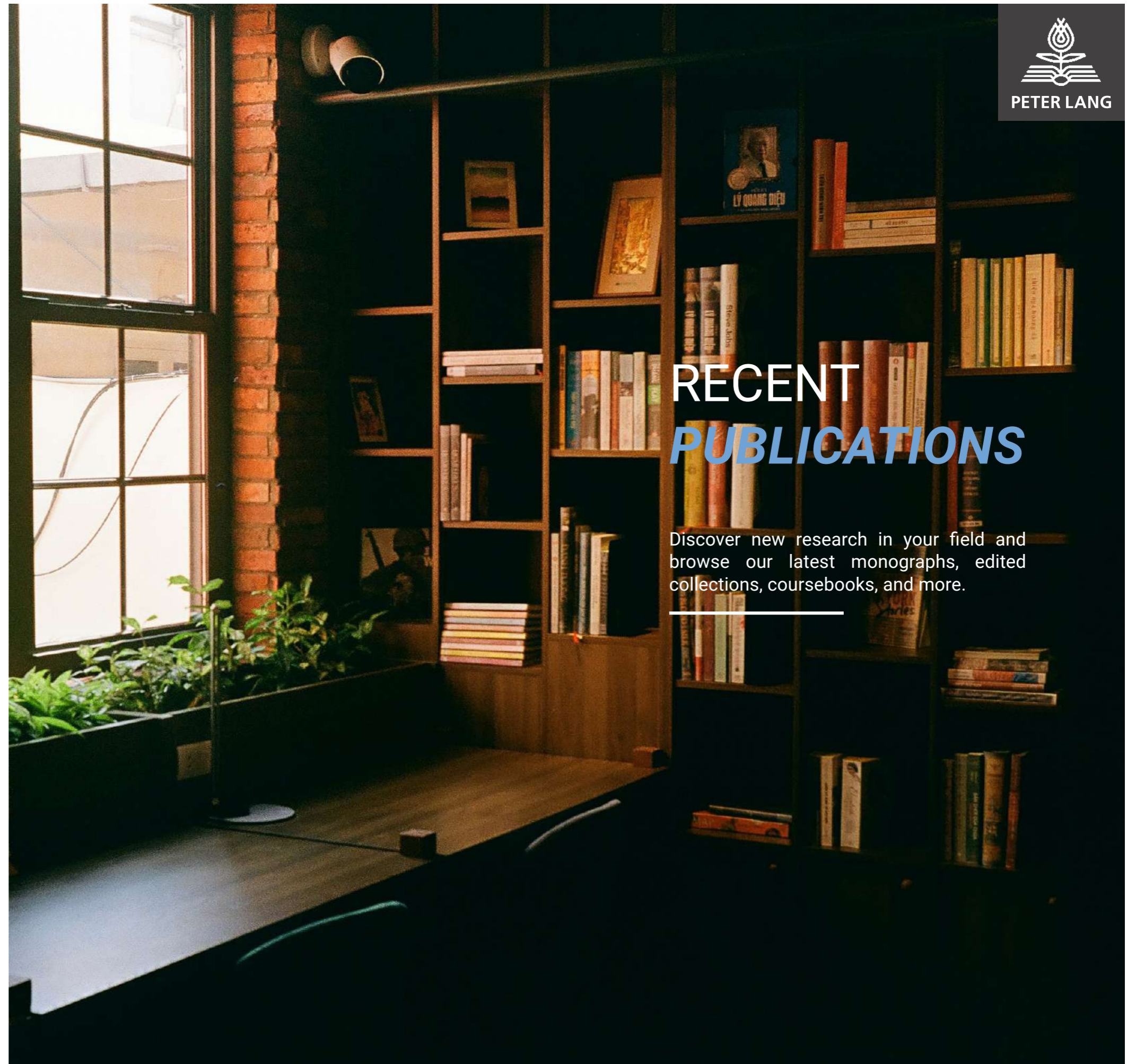

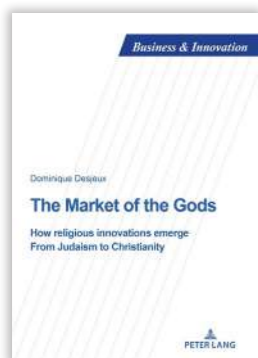

2,000 years ago, Judaism was becoming an attractive product in the market of Mediterranean religions. Yet it was Christianity that won the day. Innovation anthropologist Dominique Desjeux offers an unexpected solution to this oft-revisited enigma. In the year 70, the Temple of Jerusalem was destroyed. The Jews were in danger of disappearing, even though they represented nearly 8% of the empire's population. To survive, the Jews had to make a strategic choice between several controversies: the resurrection of the dead, proselytism, the application of circumcision and dietary prohibitions. One school of thought proposed refocusing on the purity of rules. This later gave rise to Rabbinical Judaism. Another Jewish current favored globalization. It proposed a religious product that was easier to disseminate. It did away with circumcision and kashrut, included eternal life, which reassured against the uncertainties of the future, and baptism, which simplified the rituals of purification. This current was excluded from synagogues. A few centuries later, it gave rise to Christianity. Any resemblance to today's innovations and crises is not accidental.

El presente libro realiza un análisis de la pobreza multidimensional y de las desigualdades persistentes en los pueblos indígenas que habitan Medellín y, en comunidades que habitan el territorio rural disperso en Colombia, con foco en el departamento de Vaupés. En el caso de Medellín, llama la atención que dicha pobreza se vive al interior de una ciudad pujante, pero no ajena a las dinámicas de altísima desigualdad y a los mecanismos causales subyacentes en este fenómeno en el contexto latinoamericano. En cuanto al territorio rural disperso, la autopercepción de la pobreza es coherente con la heterogeneidad que hay en los grupos sociales. El análisis de la pobreza y la desigualdad pluriétnica es desafiante, por ende, se deben vincular sus causas y develar algunos mecanismos estructurales y persistentes en los indígenas. Algunos de estos mecanismos están aunados a hechos y realidades en el territorio de origen y a las rupturas entre las dinámicas de lo rural y lo urbano.

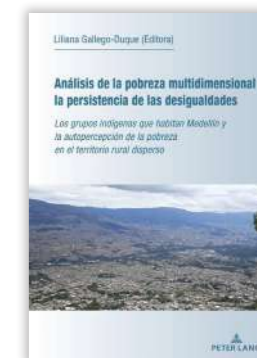

This book comprises two empirical studies that use econometric techniques to examine loan loss provisions in Southeast Europe (SEE). The first study applies the Generalized Method of Moments estimator to a dynamic panel dataset, shedding light on specific loan loss provisioning practices. This study makes a unique contribution to the field, extending empirical evidence on discretionary and non-discretionary components of loan loss provisions in SEE. Additionally, the analysis of outlying observations offers interesting insights into potential motives influencing decisions on loan loss provisions. Filling a gap where research in SEE is infrequent, the second study uses individual structural vector auto-regression (SVAR) models for individual economies and panel SVAR models for SEE EU states and the Western Balkans, forecasting response functions of loan loss provisions to adverse GDP and employment shocks.

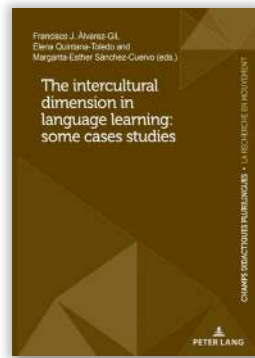

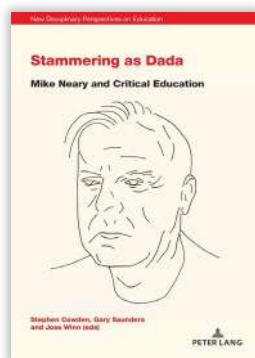

Mike Neary was a renowned critical educator, Professor of Sociology at the University of Lincoln, and a founding member of the Social Science Centre, Lincoln. He died in January 2023, and in the months prior to his death, the editors of this book met with Mike and, with his guidance, worked with him on a collection of his writings. Mike was once asked why he wrote and he responded, "I write for the future". This book gathers some of his key writings to keep alive the critical legacy which Mike's life and work embodied. Neoliberalism, after decades of reform, continues to steer educational policies around the world. As private enterprise encroaches public education, schools are held accountable, tangled up in an internationally competitive culture of achieving benchmarks that meet technically managed standards. Not only is it academic performance that is audited but also codes of behavioral conduct. As behaviour remains one of the most dominant discourses of schooling, it is discipline policies that are critiqued in this book, framed by tracing genealogical, historical, and political patterns of discipline practices in schooling from 16th century Europe through to 21st century Australia. Two in-depth, ethnographic case studies conducted in Western Australia (where the author was both teacher and researcher), are shared as theoretical tools to provide insights into how behavior management and discipline policies are enacted within the field of institutional secondary schooling. As an alternative to the Neoliberal School, it is instead the voices, interpretations, and experiences of young people themselves, together with the voice of the author as narrator and theory-maker that speak back to neoliberal behaviour and discipline policies. 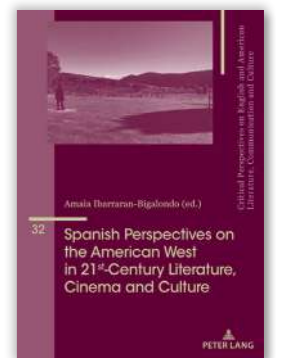

This study combines a literature review from a macro perspective and case studies from a micro perspective to reveal the communication and reception of Polish theatre in China, starting from the reception-end to explore the factors that influence the communication of Polish theatre. The literature review provides an overview of the development history and the current situation of Chinese modern theatre, and traces the communication footprint of Polish theatre in the hundred-year development of Chinese theatre on a timeline. The selection of case studies considers two perspectives: theatrical theory, and theatrical productions. Thus, the theatrical concepts of Polish theatre master Jerzy Grotowski and three Polish/Sino-Polish theatrical productions performed on the Chinese theatre stage since the second decade of the new century are selected for study. This study also explores various topics around theatre and cross-cultural communication, such as theater ecology and development, theatrical creation, actors, audience reception, appropriation of cultural resources and cultural tolerance, mediation of values at the reception-end, and the role of language, translation and new media in cross-cultural communication.

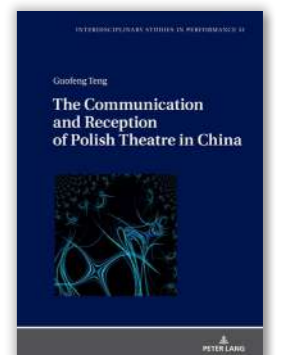

The British Indian Civil Service was a small elite, which administered and governed a vast population. From their number were drawn the Governors of the various provinces. 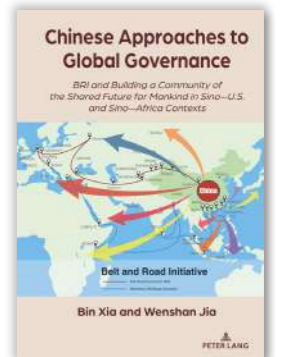
President Recep Tayyip Erdoğan has been playing the authoritarian's game for some time now. Under the polarizing, tense and uncertain conditions of this regime, segments of society in Turkey are still actively resisting to the onslaught of authoritarian measures, coalescing at diverse sites of repression, and protesting against the lack of transparency, arbitrary state actions against citizens, or outright extractivist practices against humans and nature. In this volume, we continue with our critical task of both documenting this resistance and detailing, examining, and analyzing the backsliding of one of the democratically elected governments of the twenty-first century into an authoritarian regime that is domestically punitive and regionally aggressive.
